09/08/2017, 18:35 hours, I, Officer Niven, was dispatched to Prestige Clinic, 931 Ridge Road, for a threatening report.

Upon arrival, I spoke with Dr. Jay Joshi, who said that he had just recently fired an employee, Monica Pineda for allegedly writing false prescriptions to herself using Joshi's prescription pad. Joshi said that earlier in the day on 09/08/2017, a male subject who is believed to be Pineda's brother, came to the clinic and said that he would break out the windows to the clinic and hurt anyone who threatened his sister. Joshi had no information for the brother. Joshi was unable to tell me what kind of vehicle the male subject drove as well. Joshi requested the incident be documented and extra patrol provided. Joshi was also told to call 911 should the subjects come back to the clinic to have trespass warnings issued to them and have the male subject identified.

Narrative

On 09/22/2017, at approximately 13:08 hours, I, Sergeant Martin, was dispatched to Prestige Clinic, 931 Ridge Road, Suite B, in reference to a Hit and Run Collision involving a Jeep that had just fled eastbound on Ridge Road. Officer Niven was in the area when the call came out and located and stopped a Jeep matching the description given in the 2000 block of Ridge Road just a few moments later. I proceeded to the scene of the collision to gather information. Upon my arrival, I was provided with the name of the suspect, Debra Kirk, by the victim, Deanna Howard, who is an employee of Prestige Clinic. Debra Kirk was the individual who Officer Niven had located and stopped, see his supplement for further information. D. Howard informed me that Kirk is a patient at the clinic, and that she had been denied additional prescription medications due to her already showing signs of impairment. D. Howard said that Kirk became infuriated when she could not get more medications and she stormed out of their suite, got into her Jeep, and backed up at a high rate of speed, directly into the front passenger side corner of her Acura TLX. D. Howard then stated that Kirk, who was aware of the collision due to the significance of the impact, fled the scene without any attempt to comply with Indiana state law requirements after a collision. I did observe fresh damage to the front passenger corner of the Acura, consistent with a significant impact, with scuffs and what appeared to be at least one hole punched through the outer bumper cover. I relayed this information to Officer Niven, who then detained Kirk for Failure of Duty and for his OWI investigation based on his observations of Kirk's demeanor. I then spoke with Ashley Howard and Gabrielle Flaherty, who were standing near the reception counter in Suite B and had a clear view of that area of the parking lot. A. Howard said that she thought Kirk's Jeep was impressive and that she had told Flaherty to take a look at it too. Both witnesses said that they were watching the Jeep because of their liking how it looked and that they had seen the whole event unfold. Their account was consistent with D. Howard's and they described seeing the Jeep rock back and forth when it struck the Acura. They advised that they had seen Kirk moving back and forth, similar to a whiplash motion, so there was no way she was unaware that she had struck another vehicle. I was also give Dr. Jay Joshi's cell phone number to speak with about his observations.

I then spoke with Jamie Browne, who is an employee in Suite A. Browne said she was standing in front of the reception desk when she heard screeching tires and a loud crash, which drew her attention. She said she immediately looked out of the window and observed a Jeep with wood protruding from the back leaving the area at a high rate of speed. Officer Niven did observe wood protruding from the back of Kirk's Jeep when he stopped her. Once I got back to the Munster Police Department, I called the number I had been provided for Dr. Joshi. A male answered the phone and identified himself as Dr. Joshi. Dr. Joshi told me that he had been Kirk's physician for a substantial amount of time and that he had recently become concerned with her behavior and consumption of prescription medications. Dr. Joshi told me he spent approximately 20 minutes with her trying to help guide her away from the harmful behaviors he observed, and that Kirk, who he believed to already be impaired, became irate when he refused to provide her with more medication. Dr. Joshi said that Kirk stormed out of his office, and that he had not tried to stop her because he did not know she was driving since she had stated to him she had gotten a ride there.

See Officer Niven's supplement for his observations and actions regarding his involvement with Kirk. Kirk's Jeep was removed from Wicker Park, where Kirk had pulled into when she was stopped, by Stan's Towing and taken to their lot for safekeeping.
