Re: Addendum to Enrollment Services Contract ("Addendum")

Dear Seth:

Thank you again for your current enrollment in the EAB's Undergraduate Enrollment Services/Enroll360 program (the "Program"). New Mexico State University ("Organization" or "you") enrolled in the Program with EAB Global, Inc. ("EAB"), pursuant to the agreement dated 12/31/21 (as may be previously supplemented and amended, the "Agreement").

This addendum ("Addendum") to the Agreement shall confirm our discussions regarding the update to the Scope of Services in connection with the utilization of the Parchment Platform, in lieu of SENDedu, for the electronic submission of documents required for admissions (the "Parchment Services"). This Addendum is separate from and does not affect the Agreement, except that the terms and conditions in the Agreement are hereby incorporated and made a part of this Addendum. All terms and conditions and services specified under the Agreement, including Term dates, invoicing, and payment, remain in full force and effect. In the event of a conflict between the Addendum and the Agreement, then the Addendum shall control only for the Parchment Services detailed below and terms and conditions specified herein.

I. New Services

Under the terms of this Addendum, Organization may have access to the Parchment Services described below, at such time as EAB implements the Parchment Platform in its sole discretion:

The Parchment Platform will be available for students applying with an EAB Custom Application to enable secure electronic submission of documents required for admissions, including a high school transcript. EAB will process and facilitate transfer of student applicant data to Parchment to be joined with documents transferred through the Parchment Platform.

The Parchment Platform shall replace SENDedu in its entirety.

II. Enrollment
