## RE: CALIFORNIA PUBLIC RECORDS ACT; NOTICE OF DETERMINATION DECEMBER 11, 2024; NOTICE OF DETERMINATION

Bradford Davis and Yelena Dzhanova,

The Newport Beach Police Department received your California Public Records Act request on December 11, 2024. This response will serve as the Department's notice of determination as to whether the request in or part seeks the production of non-exempt, non-privileged, disclosable public records in the possession of the City, pursuant to the California Public Records Act ("Act") (Gov. Code §§ 7920.000 et seq.).

Based on your request, all non- exempt, non-privileged, disclosable public records in possession of the Department responsive to your request have een gathered and will be produced herewith.

- 2. "All phone, text, or email correspondence between your department and Oklahoma City Thunder staff referencing Joshua Giddey (DOB 10/10/2002) between the following dates: 11/22/23-5/23/24"
  - All responsive records have been included.
- 3. "We're also requesting 911 calls, arrest reorts, and investigative records (which can include chronological records of events, logs, witness lists, interview notes from officers examining the case, photos and videos included in the case file, search warrant affidavits, case summaries, and charges recommended to the prosecuting agency) referencing Joshua Giddey (DOB: 1/10/2002) between the following date range: 11/22/23-5/23/24."

The Newport Beach Police Department must deny this portion of your request due to following exemption in Accordance with the Act.

- <u>Investigative Record Exemption</u>: Records of complaints to, or investigations conducted by, or records of intelligence information or security procedures of ...any state or local police agency, or any investigatory or security files complied by any...local agency for correctional, law enforcement, or licensing purposes are exempt from production. (Gov Code § 7923.600(a)); *County of Los Angeles v. Superior Court (Kusar)* (1993) 18 Cal.App.4<sup>th</sup> 588, 595; see also *Williams v. Superior Court of San Bernardino County (Freedom Newspapers, Inc.)* (1993) 5 Cal.4<sup>th</sup> 337.)
