PSB reviewed the two officers' cameras starting around the 33 minute mark as they worked with the nursing start transition to the facility. Between the two cameras, PSB observed Officer Ferreria tell Officer Kubes they would take her inside then go around to would officer Ferreria reminded Officer Kubes about officer safety and to be prepared for her to when Officer Ferreria opened driver's side rear door, would asked for a supervisor or watch commander. This call for service (1136696) was a follow up call stemming from an earlier call (1136440). This call stemmed from telling 911 operators she will forficers do not come to her house and resulted in being transported to which she agreed to.
Fact Finding Interview with Officer Ferreria  During my phone call with Officer Ferreria, he told me that had claimed he had grabbed her around the neck while walking her into  Officer Ferreira said as he and Officer Kubes were escorting who was cuffed with her hands to the rear, attempted to head but him. He said he prevented her from doing this by putting his hand to he back of head, and with the help Officer Kubes, push her head and body forward maintain some space and to gain compliance from I told him I would review his Body Worn Camera and review the incident.
Fact Finding Interview with Officer Kubes  Officer Kubes stated he was standing to the right of sassisting Officer Ferreira in escorting in to the facility when flung her head towards Officer Ferreira. He said he maintained control with one hand on her right arm and pressed down on the back of her head as they walked her in to the facility.

Body Worn Camera of Officer Kubes  At approximately the 35:00 mark, Officer Kubes is assisting Officer Ferreira in escorting into the facility.  It is seen on his Body Worn Camera flinging her head towards Officer Ferreira. Officer Kubes has both of his hands on right arm and Officer Ferreira Is seen placing his right hand behind head, forcing her away from them.
Conclusion Based on the review of each officer's Body Worn Camera and fact-finding interviews:  claims that officers did not have Body Worn Cameras was obviously incorrect.  also claims on her recorded phone call to PSB that both officers were wearing hats was incorrect.  A Field Interrogation card was completed under Incident Number 20-1136440  In reviewing both officers' Body Worn Cameras, I found no evidence that was picked up by the neck and choked.  is clearly seen on both camera's flinging her head towards Officer Ferreira in what appears to be an attempt to head butt him. Officer Ferreira makes contact with chin and cheek area to push head away from him in order to stop that attack. His hand is then placed on the back of head in attempt to control her movements in order to prevent another attack.  has been the subject of 40 calls for service since May 15. I responded to her residence the day after she was petitioned because she was worried a business was being ran out of the house she lived in (She

made no mention of this incident during the contact.

On July 22, I placed a phone call to from my desk phone to notify her of my findings to both of the listed numbers and there was no answer.

On July 23, I placed a follow up phone call to from my desk phone to notify her of my findings, and again there was no answer.

I found no evidence of any misconduct or policy violation by either officer. This concludes this inquiry.

On 04/29/2021at 0806 hours I attempted telephone contact with Mr. Gudeta Fufaa at There was no answer and the phone went directly to voicemail. I identified myself as Sgt. Selvius #8745 and left a message leaving my duty cell phone number for him to call me at his earliest convenience.

\*\*\*\*\*Follow up with Officer Wilson\*\*\*\*

On 04/29/2021 at approximately 0815 hours I followed up with Officer Wilson who was the primary Officer on scene. On 04/24/2021 Officer Wilson called me and advised me of the call he was on. I advised Officer Wilson we would not be forcing entry into the house to arrest a trespasser. Officer Wilson stated Mr. Gudeta Fufaa told them that the subject, Mr. Leon Bryant was evicted 3 days prior to 04/24/2021. Mr. Gudeta Fufaa stated he, himself changed the locks on the property while Mr. Bryant's property was still inside the residence. Mr. Bryant returned and cut the lock, forcing entry into the residence to remove his property. Officer Wilson advised, Mr. Gudeta Fufaa told him the constable had placed a notice on the door stating no trespassing. I advised Officer Wilson there is a 14 day grace period for the tenant to get his stuff out of the house and recommended telling Mr. Gudeta Fufaa to obtain an order or protection or injunction against harassment as well to assist with getting Mr. Bryant out of the house. Officer Wilson relayed the information to Mr. Gudeta Fufaa and advised him we would not be forcing Mr. Bryant out of the house to arrest him for trespassing.

I reviewed the body worn camera from the Officers assigned to this call and did not observe any policy violations.

On 04/29/2021 at approximately 1015 hours Mr. Gudeta Fufaa arrived at the Maryvale Precinct to have an injunction against harassment served against Mr. Leon Bryant. I arrived at the station to contact Mr. Gudeta Fufaa. My body worn camera was activated during my conversation with Mr. Gudeta Fufaa. He was very cooperative and receptive from our conversation. Mr. Gudeta Fufaa advised he contacted his attorney and his attorney stated the 14 day grace period for Mr. Bryant is over on 05/05/2021. I advised Mr. Gudeta Fufaa if Mr. Bryant arrives at the house he needs to contact police in order to get any remaining items out of the house. If Mr. Bryant forces entry into the home then he is trespassing and Officers will attempt to arrest him. Mr. Gudeta Fufaa said he initially filed a complaint because he was upset at Officers for not arresting Mr. Bryant. After our conversation Mr. Gudeta Fufaa understood landlord/tenant act more clearly and was appreciative of our service. I advised him there was no policy violations from any of the Officers and that I would document our contact.

Ms. Guzman was a runaway juvenile from Ms. Claytor explained to Officer Kubes contacted Ms. Claytor, by telephone to take custody. Ms. Claytor explained to Officer Kubes that Ms. Claytor said Ms. Clay
PSB investigators contacted Ms. Claytor by phone. Ms. Claytor's complaints were the same but emphasized her

"disgust" Officer Kubes told that she did not want her anymore. PSB investigators advised Ms. Claytor that Officer Kubes's supervisor would be made aware of the incident and possibly seek training for Officer Kubes and his squad. Ms. Claytor said that would be great. Ms. Claytor appreciated the contact from PSB investigators to discuss her issues and concerns.
PSB investigators contacted Sgt. Eric Moser #9299 by email and informed him of the incident and complaint. PSB investigators advised Sgt. Moser on seeking for Officer Kubes and his squad.
Based on the available information, this incident does not rise to the level of a PSB investigation. PSB investigators found Ms. Claytor's complaints to be true. Officer Kubes did not know what meant and called both are not misconduct or policy violations.

Complaint received by Sgt. Jackson, Professional Standards Bureau:
On July 6, 2022, Mr. Marlo Stanek walked into the Professional Standards Bureau (PSB) and met with PSB investigators. Mr. Stanek explained he was arrested on May 21, 2022, at for an outstanding warrant. Mr. Stanek said when he was arrested, he was working on his vehicle in a private parking lot, and the officers who arrested him did not allow him to make arrangements to have someone pick up his vehicle even though he told the officers he could have someone pick up his vehicle. Mr. Stanek said when he was arrested, he was in jail for forty-one (41) days, and when he got out of jail, Western Towing wanted \$2000.00 to release his vehicle. Mr. Stanek also said he believed Western Towing may have contacted the loan company of the vehicle when he was in jail, but he was not sure. Mr. Stanek said his vehicle was parked in a private parking lot, and his vehicle should not

have been towed.

PSB investigators reviewed Officer Alexander Kubes' #10954 supplemental report from IR202200000765590, and the Phoenix Police Department Vehicle Removal Form Officer Kubes completed in reference to Mr. Stanek's vehicle. Officer Kubes noted in his report that on May 23, 2022, he had Mr. Stanek's red Chevrolet impala towed by Western Towing for safekeeping.

Based on the available information, this incident does not rise to the level of a PSB investigation. Further fact finding and disposition will rest with the officers' chain of command. This inquiry was forwarded to Sergeant Billy Beauchamp #8834 via Blue Team. Please contact the complainant to gather any additional facts you may need to complete this Blue Team or potential investigation. Please determine if Mr. Stanek's vehicle was towed appropriately. On August 15, 2022, at approximately 1 p.m., Mr. Stanek visited the Professional Standards Bureau in person and requested to speak with Sqt. Jackson. Sqt. Jackson was not available and Mr. Stanek politely discussed his high level of frustration that he has not heard anything from the supervisor at the precinct where this incident occurred. Mr. Stanek said he wanted to discuss the status of his complaint with Sqt. Jackson and what additional options might be avaiable to him to resolve his concerns. - Det. Cosner 8/15/2022

Field investigation by Sqt. Beauchamp, Mountain View Precinct:

On 09/02/2022 at approximately 2010 hours, I called Mr. Stanek with no answer. I left a message with my telephone number and stated I would be doing follow up and give him a call the next morning.

09/03/2022 at 0555 hours, I called Mr. Stanek by telephone. I received no answer and left another message. I will be calling again later this evening.

09/12/2022 at 0511 hours, I called Mr. Stanek by telephone. I received no answer and left another message. I explained in the message to call me back and left my desk number . I explained to Mr. Stanek via recorded voice message I would be closing out his complaint if I did not here from him today.

09/12/2022 at 2249 hours, I have not heard from Mr. Stanek and could not get in touch with him to explain my completion of this investigation.

After review of Body Worn Camera from Officer Kubes of the day of this incident, I was able to determine Officer Kubes to act in a very kind, courteous, and professional manner during his contact. Officer Kubes explained to Mr. Stanek why he was being arrested and they would have to Tow his vehicle from the property. Mr. Stanek never complained of this and in fact stated he was going to have his vehicle towed from the property anyway. During the officers call and investigation it was apparent the driver side of Mr. Stanek's vehicle could not be rolled up or secured properly. Mr. Stanek had a plethora of personal belongings with him scattered throughout the vehicle and outside on the floor as it appeared Mr. Stanek may have been living out of his vehicle. To keep Mr. Stanek's vehicle, personal belongings inside the vehicle safe and in the best interest of Mr. Stanek, the officers impounded the vehicle for safe keeping to avoid theft or vandalism. The area the vehicle was in was a high crime neighborhood and was very visible in the public view. The Officers had to make an arrest of Mr. Stanek due to his outstanding felony warrants.

After review of report, further fact finding, and interview of Officer Kubes, and review of Body Worn Camera it is found Officer Kubes was in policy during the incident involving this call. The complaint is unfounded and their is no further action taken or needed at this time.

"Mr. Stanek contacted PSB alleging his vehicle was improperly towed which resulted in a storage fee of approximately 2000.00 dollars. He expressed frustration he had no police contact from the immediate supervisor of officers involved.

Sgt Beauchamp contacted Mr Stanek on two different dates to inform Mr. Stanek of the findings and to gather any further information from the complainant and he received no response after leaving voice messages for contact.

I reviewed all BWC and attachments; after doing so I'm in agreement there is no policy violations on the part of officers involved and the complaint be exonerated with no further action - please forward through the chain of command for review and approval of findings."

On September 8, 2022, at approximately 0908 hours, while on-duty, Officer Kubes #10954 was westbound in the area of North 36th Street and East McDowell Road looking for a subject passed out in a vehicl Turner was stopped in the left hand turn lane for eastbound traffic on East McDowell Road to m turn onto North 36th Street. As Officer Kubes passed her, his drivers side view mirror struck the drivers side view mirror of Mrs. Turner's Kia Sorento. The damage to the Police Tahoe required the housing to be snapped back on, while the damage to Mrs. Turner's vehicle was a broken drivers side view mirror. There was no further damage to either vehicle. Officer Kubes advised Sergeant Wesley #5372 who responded to the scene.

Officer Welch #9374 completed the accident report and took photographs of the scene as well as both vehicles involved in the collision. The marked Police Tahoe, Vehicle 011770, required the drivers side view mirror housing to be snapped back on, and Mrs. Turners Kia Sorento had damage to the drivers side view mirror.

Complaint received by Sgt. Rincon, Professional Standards Bureau:

On December 6, 2022, Mr. Christopher Jones Yewcic called the Professional Standards Bureau (PSB) and said he wanted to make a complaint. After his release from jail, Mr. Yewcic could not locate his wallet and cell phone from his prisoner property or at any police facility. He could GPS his cell phone and noticed it was tracking to an unknown residence, not a police station. Mr. Yewcic did not provide the cell phone's location during the phone call. Mr. Yewcic claimed that during the arrest, Officer Alexander Kubes #10954 told him his personal property, which included cigarettes and a wallet, would be placed inside his apartment.

PSB investigators found his arrest on October 09, 2022, at 0436 hours and reviewed the associated body-worn camera (BWC) footage. The BWC video footage showed Officer Kubes, along with Officer Ryan Schrank #10994, taking Mr. Yewcic into custody for Misconduct Involving Weapons. During the encounter, Officer Kubes placed Mr.

Yewcic's cell phone on top of the police Tahoe. Mr. Yewcic did not possess an actual wallet but had loose cash and some cards, which included a debit/credit card and Arizona ID. PSB investigators could see the items taken from Mr. Yewcic's back right pocket on Officer Kubes and Officer Schrank's BWC. Officer Kubes then walked to Mr. Yewcic's apartment and placed all items on the kitchen counter at the request of Mr. Yewcic. Officer Xavier Parra Jimenez #10805 occupied the apartment as an official crime scene.

PSB investigators observed Officer Parra Jimenez inside the apartment, gathering evidence after Mr. Yewcic admitted to firing his handgun inside his apartment. Officer Parra Jimenez's BWC shows Officer Kubes enter the apartment, where he placed the loose items on the kitchen counter. PSB investigators observed Mr. Yewcic's property on the counter by the front door as Officer Parra Jimenez walked out of the apartment, closing the door behind him. PSB investigators could not determine if officers had the front door secured adequately. Officer Kubes handed Officer Parra Jimenez keys to the apartment and explained to "grab a sweatshirt" for Mr. Yewcic and to "lock up as you leave," indicating to secure the apartment. PSB investigators could not locate any BWC activation from Officer Parra Jimenez showing him entering the apartment and locking it with the key.

PSB investigators reviewed the original report and did not locate the cell phone listed as property or evidence.

Officer Kubes and Officer Parra Jimenez drove away to complete the booking process. There were no BWC activations from either officer from this point forward while Mr. Yewcic was in police custody. PSB investigators could not locate any BWCs showing the cell phone being recovered. PSB investigators reviewed the Maricopa County Sheriff's Office (MCSO) prisoner property report and did not find a cell phone listed.

PSB investigators spoke to Mr. Yewcic on December 19, 2022, via telephone. Mr. Yewcic said he was released from jail 48 hours later (10/11/2022), and when he returned to his apartment, he noticed that his "wallet," which consisted of loose cash with some cards secured by a rubber band, was found by the front door of his apartment. Mr. Yewcic said it appeared he was missing money because the amount seemed lower than he remembered, but he was not 100 percent positive.

Mr. Yewcic explained that his cell phone was still missing at the time of the arrest, but he could track it to an unknown address. Mr. Yewcic explained that the address was "a couple of miles southwest" of Mountain View Precinct. The GPS track shows a house with a pool in the backyard.

Based on the available information, this incident does not rise to the level of a PSB investigation. This inquiry was forwarded to Sergeant L' Tresea Aberra #10111 via Blue Team. Please gather any additional facts regarding the cellphone to complete the Blue Team or potential investigation. Mr. Yewcic stated his property was not left on the kitchen counter or an additional counter where he would normally leave his items. Mr. Yewcic was taken into custody for a Shannon's Law violation. He advises the officers to get a house key from his vehicle to secure his apartment and his property. After speaking to the officers on scene, they state they removed all of his property and properly placed it his home, locked and secured it. I watched all body worn camera regarding this incident and it shows Officer Kubes placing items belonging to Mr, Yewcic on his kitchen counter. Officer Jimenez reminds Officer Kubes in the video to lock the apartment and both officers exit his residence. Based on the information provided and speaking to both arresting officers, no violations from officers were discovered.

On 1/7/2023 I attempted to contact Mr. Yewcic via the number he has listed to see if he could provide any additional information or had any additional concerns. The number he has provided is no longer in service.

"All indicia associated to the listed incident was reviewed. I agree with Sgt. Aberra and Lt. Gonzalez assessment. The totality of review, to include review of Body-Worn Camera video, from Officers presents, clearly depicts a chain-of-custody of Mr. Christopher Yewcic's property being placed, and secured, inside his listed residence at the time of contact. In addition, Body-Worn Camera video depicts Mr. Yewcic advising Officers that his residential keys are inside his vehicle, which would be used to secure his personal items inside his residence.

No employee misconduct. Forward to PSB for review and closure."
