<p>In Car Video Available Body Worn Camera Used NARRATIVE</p> <p>On 06/30/2023 at approximately 0854 hours, I, Officer Zachery Grass was working uniformed patrol. At this time Officer Argitis and I were dispatched to the area of 52 Hanover Street for a report of a black male and a hispanic male "smoking crack" behind a building.</p> <p>When I arrived in the area I was flagged down by a construction worker that there was a male causing a disturbance in the middle of Hanover Street. I turned my cruiser onto Hanover and there was a black male, wearing only a robe, standing in the middle of the street. This male was later identified by his Maine Driver's License as, Gabobe Douale (DOB [REDACTED]). Gabobe saw me and stayed in the street, yelling for me to run him over. Gabobe walked up to my cruiser and spit on the hood. He continued yelling for me to "do something". He walked over to my drivers side door and spit</p>

I pulled my cruiser into the parking lot at the top of Hanover Street and asked Officer Argitis to meet me there. Gabobe walked over to Dyer's Variety (45 Portland Street) and continued his disorderly behavior. He was yelling at the construction workers that were walking by and continued yelling towards my cruiser saying "Do something white boy". I pulled my cruiser onto Portland Street and was going to drive to the Community Policing office at 26 Portland Street. Gabobe ran into the street and laid down in the middle of the road. As I slowly drove by, Gabobe got up and chased after my cruiser. I pulled over in front of the Community Policing office as Officer Argitis arrived in the area. Gabobe then chased after Officer Argitis' cruiser.

Officer Argitis and I got out of our cruisers and made contact with Gabobe on Portland Street. Gabobe repeatedly opened his robe on purpose and exposed his penis to officers and all of the citizens on Portland Street. Gabobe threatened to kill Officer Argitis. Gabobe tried to walk up on Officer Argitis and I and get in our face. He repeatedly asked for us to hurt him and arrest him. Gabobe was laughing saying something to the effect of "I fucking love this shit, this is funny to me". Officer Schertz arrived on scene and Gabobe tried to get in his face as well. Gabobe would not get out of the of the street. Officers told him numerous times to get out of the street, but he refused and kept telling us to arrest him. Several times Gabobe ran over to the people in front of Dyer's, got in their face and threatened to hit them. One of the males in front of Dyer's said Gabobe was his friend and he was extremely high on illegal narcotics.

I verbalized a disorderly conduct and obstructing a public way warning to Gabobe. Gabobe again blocked the road as a car was trying to turn onto Hanover Street. During this entire interaction Gabobe's robe was open and his genitals were exposed to officers and everybody in the area.

Gabobe was placed under arrest at this time and transported to Cumberland County Jail by Officer Argitis. Gabobe was charged with Indecent Conduct, Disorderly Conduct and Obstructing Public Ways.

I spoke with several construction workers after Gabobe was arrested. Nobody wanted to give a statement to me, but they stated Gabobe has been threatening them for the past few days. They stated one of these times Gabobe threatened to go get his gun from his house ([REDACTED]) and pistol whip them.
