### NARRATIVE

On 07/22/2023 I, Officer McLean, was working routine patrol in full uniform and a fully marked police cruiser (1003). At approximately 1304 hours, a female named Clara Robinson called the Portland Regional Communications Center (PRCC) stating there was a white male in his 40's was in Lincoln Park, located at 79 Pearl Street, and he was completely naked. I arrived to the park at 1306 hours. Lincoln Park is a public park in a busy section of downtown Portland, that sees a lot of vehicle and pedestrian traffic.

I entered the park from the Congress Street side. I observed approximately 10 people in the park. They all were stopped and looking in the direction of the fountain, pointing towards it. They appeared alarmed and surprised by what they observed. As I approached the fountain, I observed a white male, later identified as Jacob Horwitch (██████████), sitting on a bench. He was completely naked,

slumped over on the bench, groaning. His right hand was holding his genitals. There was a pair of black shorts approximately 5 feet from the bench. I believed these to belong to him. I addressed the subject but he did not answer. I tossed the shorts on his lap and he stated "Hey" and he woke up. I asked if those were his shorts and he stated yes, and I instructed him to put them on. He stood up from the bench, exposing his genitals in full view to myself. I was alarmed to see Jacob completely naked in such a public setting. I asked why he was naked. He told me he did not know, he fell asleep with his clothes on and now he was completely naked. I asked him his name, and he stated it was Jacob Horwitch, who I then recognized from previous police interactions.

I asked dispatch to run Jacob. They advised he had a warrant out for his arrest. Officer Curtin and I placed Jacob in handcuffs without incident. Jacob is also on bail. One of his conditions state he must not commit any new criminal act.

I transported Jacob to Cumberland County Jail. He was accepted on his warrant. He was also charged with indecent conduct, class E (17A-854.1.A.2) and violating conditions of release, class E (15-1092.1.A).

Jacob had a couple backpacks with him with personal items. Those were tagged into Portland Police property locker #11.

A copy of Jacob's warrant and bail conditions were turned into records. A copy of the affidavit for a 48 hour hold was also turned in. The investigation was captured on my body worn camera. A digital media work order was completed.
