NARRATIVE

On 7 August, 2023 at approximately 2330 hours, dispatch received a call from the area of 47 Hanover St. about a male that was banging on and throwing things at the caller's door. I was nearby and I went to the area. As I drove down Hanover St., I observed a large black male standing on the porch of 49 Hanover St. speaking to a female. The male walked off of the porch towards my cruiser as I informed dispatch that I was on scene.

I exited my cruiser and the male walked towards me. He was wearing a zip up sweatshirt with a robe underneath it. The male spoke to me and stated that he was at his house. I asked him what his name was and he told me that he was Gabobe Douale (DOB [REDACTED]). I tried to speak to Gabobe, but he appeared to be very escalated. He continued walking towards me slowly and I backed away

from him. Gabobe began yelling at me before taking his jacket and robe off, exposing his underwear and under shirt. Gabobe was screaming something along the lines of "let's go." Gabobe appeared to square up to me, as if he wanted to fight me in the middle of Hanover St. He also smelled very strongly of poop. I informed dispatch of what Gabobe was doing and Officers Huff, Buckley, Joyce, and C. Knight arrived quickly, as did Sgt. McDonald.

As Gabobe continued to yell and walk around, he pulled down the front of his underwear, exposing his penis. He began to play with his penis as he spit towards me. Gabobe continued to yell before walking towards my cruiser and hitting the hood. Gabobe then bent over at his waist and placed his hands behind his back. Officer Huff and I approached Gabobe and placed him in handcuffs. We then walked him to my cruiser. Officers told Gabobe to get into the cruiser, but he would not sit down. At one point, he attempted to stand up and Officer Knight and I went to the opposite side of my cruiser. As I walked away, Gabobe spit on Officer Huff. See his supplement.

Gabobe was ultimately secured in my cruiser and I transported him to CCJ. Gabobe was ultimately processed at CCJ without issue and he was charged with VCR, indecent conduct, and assault. See attached bail conditions for indecent conduct. It is worth noting that [REDACTED] [REDACTED]. Gabobe's family, who was nearby, stated multiple times that Gabobe was off of his medications. [REDACTED] [REDACTED] I completed a DMWO. The ATN is 489878B.

NARRATIVE

On August 07, 2023, at approximately hours 2330, I, Ofc Curran Huff, heard Ofc C. Walles call out with a disturbance in the area of 47 Hanover St. Ofc Walles was speaking with a male (later identified as GABOBE DOUALE). Ofc Walles said on the radio DOUALE was taking a fighting stance with him. I went to the area of 47 Hanover St. and observed Ofc Walles had DOUALE leaned against his cruiser.

I exited my cruiser and assisted with Ofc Walles placing handcuffs on DOUALE. Once DOUALE was under arrest, I walked him to the rear of Ofc Walles' vehicle and attempted to place him in the cage area.

DOUALE sat on the seat but refused to get in. I asked DOUALE several times to please get into the vehicle. While, I was attempting to talk DOUALE into the vehicle, he spit onto my abdomen area. The act was intentional and I felt the contact was offensive and uncalled for. After DOUALE spit on me, other officers secured him in the vehicle and transported him to the Cumberland County Jail. I had no further involvement with DOUALE.
