On Dec 8, 2019 my son Cecil Sweeney Jr got beat by a Santa Rosa Deputy Sheriff. Me and his father had been having some issues with him hallucinating and not being himself.

Cecil had called for deputies to come over earlier that day because he thought that I had been seeing and talking to his kids mama and that I had some of his belongings. Let me explain this. His babies mama Amanda Spears had told Cecil that while he was incarcerated 6 months before Dec 8<sup>th</sup> that she had lost her house which HUD was paying for and everything in it. Almost everything Cecil had was in the house and she wouldn't tell him where all their stuff was. So he had found a crystal coaster that he said was theirs and so he thought we were helping her keep his things away from him. That isn't the truth but he believed it.

They handcuffed him and I told him I loved him and everything went wrong after that. The two male deputies took him to the patrol car and when they went to put Cecil in the patrol car he resisted and that's when they threw him on the ground face first with handcuffs behind his back and I could tell by one of the male deputies that he was doing something to hurt Cecil. Cecil was saying help me mama and when I screamed at the deputies that they were killing him one of the deputies told me that Cecil was doing it to himself and that's I didn't shut up and go inside that I was going to jail. Then the female deputy was going to take a helpless man that had already been being abused by the other deputies so I went 15 minutes and I yelled from inside my home for her not to because he has heart issues.

After 15, 20 minutes of the deputies doing god only knows what to my son they pull him up and sit him in the middle of our driveway and all I see is blood all over his head, face and shirt and I yell that he takes blood thinners they said they called the ambulance which took 10 to 15 minutes to get there when they have a station 3 minutes from our house. They had to take Cecil to the hospital where he stayed 2 days. The deputies that were involved in this didn't come back and talk to us their supervisor did. I was so worried about my son because the last thing I saw was my son covered in blood being took away by ambulance and didn't know what kind of injuries he had suffered and no one from the sheriff's dept let me or his dad know anything.

That day has changed the way I feel about deputies

They're supposed to serve and protect us, that didn't happen.

Me and his father were trying to get him some help and instead we had to watch him get abused and sent by ambulance to the hospital.

Me and his dad looked at each other after they left and said what could have been said to Cecil by the deputies to make him resist and that's all it was, was resist.

Since then ~~my~~ I asked Cecil over visiting him what happened to make him resist and that's when everything made sense. He said as soon as they were walking behind the patrol car to put him in the car that one of the deputies told him that they had been wanting to get a chance to beat his ass while he was on the ground ~~one~~ the deputy that said that ~~told~~ ~~that~~ told the other deputy to hold him down while he was pulling the heel of his shoe and stomping on Cecil's face.

They even pepper sprayed him  
in the mouth and he couldn't  
breathe so if they are saying  
that he battered them there's  
no way he never said anything  
except help me mama

I will never trust the law  
enforcement again because I  
have heard a lot of people say  
that the main abuser of Cecil  
has done this before and nothing  
has happened. I have night mares  
about this it's not justice it's  
injustice what was done to my son  
and what me and his dad had to  
witness in our own yard

Nature of Allegation(s): On 1/30/20 at approx. 8:30 Am several officers from the Santa Rosa County Sheriff's Dep. approached my house & knocked on my door. Upon answering door I was informed I had a warrant. I recognized some of the deputies and instantly asked if they would hand cuff me in the front due to shoulder surgery and they very politely complied. All deputies were very professional except Dep. Alexander #182. his aggressiveness caused me to ask if he had his body cam on and was told they don't have any. From this point on he escalated, not de escalated the situation. He asked if I wanted to get my keys & shoes & phone and I said yes. I turned

over



To go retrieve these items at which point #182 grabbed me, pushed me against the wall and said "now you are not getting anything for trying to walk away from him. I told him I was just getting my thing he told me I could get. He said he never told me I could get them but that he would and then he grabbed me by my bad shoulder & elbow, jerked me up and drug me out the door. I was screaming at the top of my lungs, "Your fucking up my arm" over & over & over. Then I saw my neighbor and hollered to her to call my parents because this deputy was hurting me for no reason and that's when #182 released me because he saw a witness. From here I was transported to Jail. After pouring out, I saw my doctor and x-rays & test were done. #182 caused tendon damage to the surgery area and I am now looking at another surgery. I want to file charges for Excessive and brutal force used on a misdemeanor warrant. There was no call for this

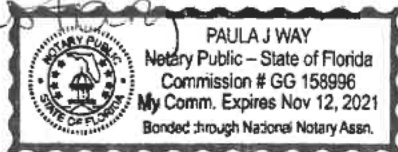

KK How it transpired. Okay. I worked, I picked up third shift at Waffle House. I started working there part time. Besides my first job. A bunch of deputies would come in. They would eat & it was fine.

MK Which Waffle House you work at?

KK One across from Walmart on 90. A lot of deputies come in. Some are regulars. Whatever, I am a friendly person. Then it turned to just be him, you know. Other deputies have messed with me, but him, particularly. He would come in & eat his lunch, & not even eat his food there sometimes & stuff just to sit. Would ask me to come & say bye to him. Blah, blah, blah. It got to like, we would flirt, but there was nothing. I never wrote my name down. I never wrote my number down. Never wrote my address down. Nothing. I never reached out to him. 221 *at all, she will at least talk to me tonight. (no reply) Tell her I understand if she*  
222 *is mad at me & I am sorry & I would be risking everything just to reach out if I*  
223 *didn't care. Then again on Thursday. Jack is wanting to know if he can call you*  
224 *here. Jack told me to tell you to call him. And then here is his number.*

225 MK And you don't know who that was

226 KK No it said buddy of Jack's

227 MK Okay. ....You only know Jack from the Waffle House? .....

228 KK Yeah. Yeah. I have never met him before.

229 MK Never met him before.

230 KK He did tell me that he was under investigation blah, blah. And I told him I was  
231 going to, I was done with the recordings. And he said "you are just like all the  
232 other girls" So I don't know if that means if you are married, you have other  
233 girls. But.

234 MK You are just like the other girls. Don't want to continue talking to a married  
235 man?

236 KK Yeah. I guess. You would think after I reached out to his wife, because you  
237 know lose your job is the last thing you want to do. So when I reached out to &

238 I talked to his wife. I told her everything, you would think that would maybe  
239 make him leave me alone, but then it just blew up from there. Now he is more  
240 crazy than ever.

241 MK What did, when you spoke with his wife. What did she say about the whole  
242 thing?

243 KK She said that she loves him & that he has done this before. And he wouldn't  
244 leave a girl alone & she threatened to go to the cops. Or go and report him. She  
245 said that he is losing grip on reality. Like he is so out of touch that she told him  
246 that she was going to call me & talk to me & he got like super jealous? Over it.  
247 ...she just said that he is moving out. And moving into a hotel. And he is trying  
248 to be with you. And I was like, there is nobody here for him to be with. Like I  
249 don't want him. And she is like, I don't know what is wrong with him. I don't  
250 know what is up with him. She has tried to call his mom & his dad. And then, he  
251 will just call me.

252 AS You mentioned that he had tried to contact you from two different instagrams?

253 KK Oh, from a fake Instagram.

254 AS How do you know it was fake?

255 KK Because he called me from that unblocked number that morning. Right? And I  
256 was like hello, it was early in the morning. And he was like 'hey how are you?'  
257 And I was like good. And he said 'I've messaged you on Instagram, but it is not  
258 my number. It is a fake number.' Then I hung up the phone. I saw that.

259 MK Another case where he was using.....I am wondering if the, the woman up  
260 north that called you...does she say the number that she has now, maybe this  
261 spoof number?

262 KK She said she tried to call the other number. There is two numbers stated  
263 receiving. And whatever. She said she tried to call the other number & as soon

264 as she said that she had a recordings, he got really angry. Was an asshole & told  
265 her some stuff & she hung up.

266 MK And the other number was yours?

267 KK Yeah. She said 'thank you for being so much nicer. The other number I called  
268 that was associated, he was just so rude.' And I was like "I'm sorry."

269 AS Did you screenshot all this as well?

270 KK Un huh

271 AS Make sure when you send that email, send this as well. And then, the other one  
272 if you have messages from it, as well.

273 KK Oh when I told him that I was going, you know, I am going to do something  
274 about it if you don't leave me alone. He's like, he sent me a screenshot of him &  
275 his baby.....in a hotel with like messages in the background. I am guessing it is  
276 the messages I sent his wife. And his wife was face timing him. And screenshot  
277 it. And sent it to him. That is why his picture is up there. But he removed her  
278 number. Or cropped her number out. I was like 'you sent this'. I said 'I never  
279 even face timed you with your baby. I never sent, I never took a screenshot.' He  
280 is like 'well here's the proof right now. That is a felony.' I was like 'don't try to  
281 make evidence against me when I haven't done anything.' Like I am a good  
282 person. I have never been arrested.

283 MK Has he ever asked for any photos or videos of you?

284 KK Un huh.

285 MK What does he ask for?

286 KK In the very beginning he asked for pictures. But ....Im, single now & just got  
287 divorced. So I created like an only fans. Only fans, blah, blah, blah. He got  
288 pictures of me & he said that he has seen all of my nudes, which is weird. He  
289 said that he has seen all of my nudes & all of Facebook & Instagram

290 MK So you have nude pictures on what?

291 KK Only Fans.

292 MK And you told him that was where your pictures would be when he asked for  
293 them?

294 KK No. No. No. No. He already knew that I had them on Only Fans. He asked me  
295 for .....

296 MK How did he know you had an Only Fans?

297 KK I don't know. But he brought it up to me. Just like how he knew where I lived.  
298 How he knew that my last name was still legally Kimsey & not Hickey when I  
299 tell everybody at Waffle House that I am Kiley Hickey. Because that is my  
300 maiden name. He knew it was Kimsey. I don't know. All my stuff is private. So  
301 I don't know how he got my.....anything.

302 MK I am old & ignorant when it comes to .....Instagram, and whatever fan pages &  
303 stuff. If we were to type in your name in a search bar, Google would it take it to  
304 the

305 KK You would have to request to see any of my things.

306 MK Okay. Okay. And who would grant that request?

307 KK Me! I would have to give you access to see any of my stuff.

308 MK Did you ever grant him access to any of that?

309 KK No.

310 MK But somehow he was able

311 KK Somehow. He said he saw all my Facebook, all of my Instagram, & my nude  
312 pictures.

313 MK Now I have touched on the Fan page. The Fan thing you were talking about.  
314 That is a paid site.

315 KK Yeah. You have to pay to subscribe & see what I do.

316 MK Okay. And does that money, all that money come to you? Or does the Fan page  
317 keep that

318 KK They take 20%.

319 MK Do they keep the data base as to who requested it?

320 KK So, if you don't sign in with your Google name. You can have anonymous user  
321 name.

322 MK That is what I am wondering. Could he have signed in with a fake name to see  
323 your pictures & you not known it?

324 KK He would have to

325 MK Do you get to see every single person that requests your

326 KK I will see everyone who subscribes. But a lot of times it will be like, okay.  
327 Here's a Tyler, a Nick, & a user blah, blah, blah. And then anonymous user,  
328 blah, blah, blah. So he must have been under one of the anonymous. If he was  
329 under Jack Holland I would have seen it.

330 MK So he, he probably to get it. But under a fake name or anonymous.

331 KK Yeah

332 MK Something like that. Okay. .... I am just trying to figure out how he would  
333 have got them. ...

334 KK I am honestly not even worried about it. I just don't want my voice  
335 ....impairing any type of future thing I might try to get. Job wise. And I don't  
336 want him to call me again.

337 MK Yeah. I understand that.

338 KK Or his wife. Just be left alone.

339 MK Yeah. I am just trying to figure out what he's. what method he is using to get  
340 things that he is getting to.

341 KK It would have to be apps

342 MK Yeah

343 KK and stuff. Because the recording was an app. The numbers look like they are  
344 from apps. Like, & I've got chunks of like call history screenshots to, where it is  
345 like 50 missed calls Jack Holland. Then I have his number associated  
346 underneath it. So, ....and then when I delete that it will be like ....5 unknown ID  
347 caller. And it is either him or his wife. So.....

348 MK Can you think of anything else?

349 AS .....No. I don't think so.

350 MK When he comes to the Waffle House to eat. Is he, you say a lot of time by  
351 himself?

352 KK At first it wasn't. I had other people coming in, but after I turned down a few  
353 deputies about me. It started to just be him.

354 MK So you all are sitting around with the cook & talking about kinks & fetishes &  
355 sexual stuff.

356 KK Anything

357 MK Is this when this kind of started? Or had it already

358 KK No. He, he had showed me a picture of his wife. I was like oh my god your wife  
359 is really hot. And he was like, 'she likes girls'. And I was like 'oh okay. Well I  
360 am a girl & she is hot.' And I think that comment alone just got him hopeful of  
361 things & nothing was ever going to happen. And.....then, it turned into....to 'do  
362 you think my wife is hotter than me?' kind of completion kind of thing. And I  
363 was like

364 MK Did you ask that of him?

365 KK No he asked that. Do you think my wife is hotter than me?

366 MK Oh, okay

367 KK Yeah I wouldn't. that's your wife. And then he would be like 'you remind me of

368 her.' 'like if I would break her heart, she would be jaded on men.' 'you remind  
369 me of exactly of what she would be like.' Okay, so do not do that to your wife.  
370 Like. I am not really sure.

371 AS Has anybody else witnessed him calling nonstop?

372 KK Yes! Yes! And witnessed him at my house. And has witnessed the phone calls  
373 where I am yelling at him to leave me alone.

374 AS Who?

375 KK My sister. Josh at Waffle House. ....I don't work at Waffle House anymore. I  
376 quit. It was just too much for me. ....So, I have had a couple of people. His  
377 wife. His wife call history. But, I just don't like the fact that he's ....my coming  
378 to talk to you all that he is going to try to get felonies on me for me sending his  
379 wife screenshots.

380 MK Don't worry about that.

381 AS If you have any problems with any deputies from this point, you can contact me.

382 MK Yeah. Like I said, he's the least of your worries. ....And, ....I can't think of  
383 anything else.....can you think of anything else that is relevant to it?

384 KK If I think of something. Can I call you?

385 MK Yes.

386 KK If he calls me again can I call you?

387 MK What you can also do is email it.

388 KK Okay.

389 MK If you get home & you start thinking, just put it in an email & send it to me.  
390 That is a work email. And, I can print it off & put it with my file. Anything &  
391 everything you have in that phone that has to do with him. Send it.

392 KK I will do. I will do. There is some embarrassing stuff.

393 MK That is alright. What I am going to do right here while we are still on the record.

394 Is, .....just get you to sign the bottom of this. I am going to have you to raise  
395 your right hand. And swear & affirm that the above recorded statement that you  
396 gave me is true & correct.

397 KK I swear.

398 MK Okay. Sign right there at the bottom.

399 KK I do not lie. My dad taught me early not to do that.

400 MK We will conclude this interview at 13:46 hours.
