14	Corporal Rios and I responded to the UCI Counseling Center and upon arrival, I received a telephone call from
16	stated to me that he was sitting inside the Counseling Center and upon arrival, received a telephone can norm

19	At approximately 1153 hours, I made contact with and asked and if a had typed the message on the Starship
20	order. admitted to writing the message but stated was not suicidal and had done it only as a joke for
21	stated did not think anyone would read the message and that was embarrassed by the
22	situation.

24	I asked if had any other thoughts of harming or others and stated, "No." stated was
25	seeking therapy at the UCI Counseling Center for other concerns.
26	
27	stated had no history of making suicidal statements or attempts in the past and that he was not currently
28	diagnosed with any mental illness. did state has shown possible signs of depression but that he was not
29	officially diagnosed or taking any medication.
30	
31	I asked if he owned any weapons (referencing the "sawed-off" portion of his message) and stated he was
32	not in possession and did not own any weapons. I later conducted a records check through the Automated
33	Firearms System which returned negative results.
34	
35	After speaking with several minutes, I determined did not meet the criteria for a 5150 WIC evaluation
36	hold. I advised was free to leave and this concluded our contact.
