Dear: Adam Steinbaugh,

Please be advised that Van Buren Township received and reviewed your recent document request dated <u>April 1, 2024</u>, under the Michigan Freedom of Information Act (FOIA). Specifically, you requested the following documents from the VBPD:

"A copy of any police report (including any records referenced in the report, such as photographs, body camera recordings, or other records) concerning any alleged violation of sec. 58 37 {Use of vulgar or obscene language in presence of law enforcement agent). That ordinance may be located at:
