

Open Source Intelligence Techniques

Law Enforcement, Prosecutors, and Corporate Security Personnel will learn the skills needed to conduct internet-based investigations. Students will learn about the current publicly available Open Source Investigative Techniques (OSINT) that can be used in intelligence gathering will be discussed. Law Enforcement Officers will gain valuable insight in learning new ways to gather intelligence from public or open sources available without the need for subpoenas or search warrants.

Covert Surveillance for Narcotics and Task Force Units

Homeland Security Training Institute (HSTI) | Classes | Covert Surveillance for Narcotics and Task Force Units

This three day training program designed for law enforcement officers who use stationary, vehicle and foot surveillance as part of investigations. The course is designed to provide the participants with the skills to safely conduct and properly document surveillance activities.

This course consists of a 4 hour classroom presentation followed by six field surveillance exercises over the next 2 ½ days. The focus will be on proper equipment, techniques, terminology, decision making, communications, and planning to avoid detection.

Topics will be taught by a team of instructors who have decades of law enforcement experience conducting covert surveillance in narcotics cases. Lecture, videos, and real-life examples will be used in the classroom portion. Open discussion and student interaction during the course will be encouraged. This class assumes no previous surveillance experience or training, and therefore the initial four hours will focus on the basics of techniques and terminology. The next 20 hours will sharpen the participant's knowledge and skills through a variety of practical exercises.

The practical exercises will be conducted in urban (Chicago), suburban and rural environments. Driving skills for Interstate highways, residential areas and rural roads will be covered. Dense city neighborhoods, apartment complexes, shopping malls, hotels and truck stops will be used as settings for the exercises. Instructors will ride in surveillance vehicles with the students to reinforce learning objectives.

- 1 Only sworn active law enforcement officers are authorized to attend this class.
- 2 Participants should dress in casual civilian dress appropriate for covert foot surveillance. No visible firearms or badges.
- An agency owned or leased unmarked police vehicle is needed. * NOTE: Two participants from the same agency can share one vehicle. The vehicle should be unmarked, not necessarily have to be covert.
- 4 Cell phone and charger.



Manual Breaching

In the age of rapid deployment and required immediate action by responding officers, training in the use of manual breaching tools is essential to the missions of patrol officers and tactical operators. Numerous active assailants have fortified the location of their attack, most notably Seung-Hui Cho at Virginia Tech in 2007. This eight-hour training contains instruction on door construction and mechanics, breaching doors and windows, alternate breach points and ingress through the breach point. Upon completion of this training, participants will be able to properly utilize manual breaching tools for high-risk entries. This course will be comprised practical exercises in SLEA's 4-D immersive tactical village, using breaching doors and windows from Breaching Technologies, Inc.





- > Assisting victims of ID theft and scams





Incident Report Writing

Homeland Security Training Institute (HSTI) | Classes | Incident Report Writing

This 8-hour seminar will instill and refresh writing skills to enhance and improve all types of reports from the simple and mundane to the complex and extraordinary. Basic grammar guidelines and vocabulary will be reviewed to streamline the reporting process and allow the students to improve their writing skills. Common misconceptions and missteps in presenting information will be discussed to highlight errors to avoid and correct habits to incorporate.

Instructional Goal

The successful completion of this course will allow students to effectively transfer notes, evidence, interviews, and follow up steps to concise and clear reports that are easily understood by readers at all levels of review. Effective report writing and communication skills are more important than ever, and those who take this course to heart will more efficiently achieve the goal of meeting peer, supervisor, citizen, and judicial review.

Topics Include

- > Understand the importance of clear communication
- > Learn how to write concisely and consistently for all communications
- > Recognize common writing errors and how to avoid them
- > Distinguish between correct and incorrect word usage
- > Possess skills to transfer notes and interviews to complete summaries
- > Master their fear of describing complex investigations in chronological order
- > More effectively present information to readers at all levels of report review


Instructor Bio

After 29 years in law enforcement, Craig Lepkowski formed his own company to provide consulting services and professional development on leadership development, evaluation of personnel, report writing, and public safety cycling to assist organizations in the ever-changing business and law enforcement environment. Craig's training and professional development experiences have reached nationally and internationally, with his most exotic experience to date being in Brazil. He has been involved with the Illinois Juvenile Officers Association, Linking Efforts Against Drugs, the Lake County Opioid Initiative, the Lake County Underage Drinking and Drug Prevention Task Force, and most recently, the International Police Mountain Bike Association (IPMBA), where he served on the board of directors from 2013 - 2022.

Craig's entire law enforcement career was with the Lake Forest (IL) Police Department where he held many positions including Patrol Officer, Youth Officer, Detective, Officer-in-Charge, Sergeant, and Commander. As Administrative Commander, he provided oversight of personnel training, vehicle maintenance, budgeting and distribution of equipment and uniforms as Quartermaster. Craig also served as the department's Public Information Officer and lialsed with numerous civic and community organizations. He also supervised all civilian employees and conducted bi-annual employee reviews, while updating department policies and procedures and municipal ordinances.

When Craig was an IPMBA Board member, he played an instrumental role in assisting with hosting yearly training conferences, updating board policies and corporate by-laws, and writing numerous articles for the international newsletter. Additionally, Craig was co-editor of The Complete Guide to Public Safety Cycling, 3rd Edition published in 2022, updating the previous 12-year-old edition.

Craig has a master's degree in Criminal Justice Administration from Loyola University Chicago, and a bachelor's degree in Spanish/English from Lake Forest College.
