Explanation of overtime request

The Willowbrook Police Department is considered an excellent, high service, community-oriented law enforcement agency. The Willowbrook Police Department is currently comprised of 27 full-time sworn officers. As a smaller agency we deploy our staff and resources in the best way possible to provide professional law enforcement services to our community. Willowbrook is home to many retail establishments in small to medium size shopping centers. With Willowbrook's close proximity to interstates and Illinois Route 83, we have seen an increase in organized retail crime offenses. Many of these incidents have involved organized criminals with aggressive tactics putting the general public at risk. The requested overtime would be used to continue the work funded last year for follow up investigations of Organized Retail Crime investigations and saturation patrols to target organized retail crime. We plan to work approximately 200 hours of patrols across the year. The details will include our many shopping centers, Hinsdale Lake Commons on South Kingery Highway, Willowbrook Square Centre, Willow Commons, and the newly constructed Willowbrook Town Center located at 7185 South Kingery Highway at the intersection of Plainfield Rd. and Illinois Rte. 83 which has numerous dining establishments and stores including Marshall's, Sketchers, GNC, Michaels, T-Mobile, Bed Bath & Beyond, J & H Décor: Flowers & More, Bentley's Pet Stuff, and Staples.

Contractual Narrative

Explain the purpose of the Contractual funding as it relates to combatting organized retail crime activities.

Explanation:

We are requesting grant funding for the second year of our Flock LPR camera agreement. The first year and the equipment installation was paid for partially from the FY24 ILAG Organized Retail Crime grant and partially from Village funds. We have installed 15 Flock Safety Falcon infrastructure-free license plate reader cameras that utilize Vehicle Fingerprint® technology to capture vehicular attributes on the main roadways or Kingery Highway, Plainfield Road, and Illinois Rte. 83 and near each major shopping center: Hinsdale Lake Commons, Willowbrook Square Centre, Willow Commons, and Willowbrook Town Center.

We are also requesting grant funding for one year of RTCC software licensing. We believe that our successes in lowering the numbers of retail theft incidents reported is directly related to the RTCC infrastructure which has been created because of these ORC grants. Our detectives have found the data developed by the coordinated efforts of our local and regional law enforcement partners through the RTCCs has been instrumental in following up on these crimes.

Only one year of software license, equipment, or maintenance contracts is eligible for funding.

Equipment Narrative

Explain the purpose of the Equipment funding as it relates to combatting organized retail crime activities.

Explanation:

The Willowbrook Police Department currently has several new crime prevention programs that we have been working on and developing over the last few years. One example is a footprint of Flock License Plate Recognition cameras throughout town. These cameras have proven to be a vital tool in investigating and solving crimes across multiple police jurisdictions. We request funding to expand our current Mobile Pro Camera System in retail areas in Willowbrook that will give critical evidence and live camera capability to identify and apprehend offenders. This system would be compatible with intelligence software such as FUSUS for real time intelligence for responding officers.

The department is also looking to purchase one Commander 3400 Video Surveillance Trailer. This full-sized Mobile Surveillance Trailer and Power Platform is perfect for rapid or temporary deployment and rugged enough for long-term use in the field. Key features of this trailer include an advanced interactive dashboard application that provides interactive SMS and email notifications, ideal for local area and regional communication and data sharing related to ORC. The department will continue to grow its partnerships with other law enforcement agencies, other departments within the Village, and the community to provide the best services possible. The technological improvements seen by these surveillance tools have impacted our retail theft incidents. In 2022, we responded to 112 incidents and made 8 arrests. In 2023, we responded to 77 incidents and made 20 arrests. We understand the importance of combining our technology with our patrols and educating our community to deter organized retail crime activities. The continuation of this funding initiative is key to our department's success both local and throughout the county.

Number of units requested, placement, and intent of use:

The 8 Mobile Pro Systems will be located at Willowbrook Commons (3); The Willows of Willowbrook (3); Patio Center (1), and Willowbrook Plaza (1). These will integrate the cameras, sensors, deterrent devices and video management software.

The solar trailer will be deployed in areas with high incidences of retail theft, and the footage captured by its cameras can be integrated into License Plate Recognition (LPR) systems for further analysis.

The requested LPR systems use high-resolution cameras and other systems to capture and convert images of license plates into alphanumeric text, which can then be cross-referenced. Our intent of use for these LPR cameras is to provide essential and current technology to be used in the investigation of retail theft crimes and to assist our neighboring agencies as needed. The use of this equipment in cooperation with law enforcement agencies and our retailers enhances our collective ability to mitigate and prevent retail crime, creating safer environments for customers and businesses alike.

Willowbrook is home to many retail establishments in small to medium size shopping centers. We are in close proximity to interstates and Illinois Route 83. Many organized retail crimes activities in our area over the years have involved organized criminals with aggressive tactics putting the general public at risk. The Village of Willowbrook Police Department is very interested in continuing our participation in the Illinois Organized Retail Crime Grant Program. We believe that we closely align with the goals of the program and can provide a significant contribution to the efforts.
