I have received the Verizon subpoena results regarding the phone number, (850) 401-9417, which was associated with the Google Gmail account. The results for the phone number advised it was registered to a [REDACTED] from Freeport, Florida. Regarding the subpoena response from TextNow, it advised, during the time of the house party, it was registered to an [REDACTED]. Further investigation into [REDACTED] advised she is from the Tallahassee area with no ties to Walton County.

I have also received the results from Cox Communications which advised the following:

Snapchat provided IP addresses [REDACTED]. First IP address is serviced by Cox and showed the owner as [REDACTED]. Second IP address from AT&T, but they advised they don't maintain IP records for cellphones. The IP address of [REDACTED] located from 3/22/22 which is serviced by Cox and belongs to the Emerald Shore Pet Hospital.

Regarding the IP addresses from TikTok, the IP address given of [REDACTED] which shows a [REDACTED] from [REDACTED] in Freeport as owner. This same IP address is also associated with the account creation IP address on 6/17/2020. Tom Casey lives with his wife per DAVID and are an older couple. The most recent TikTok IP address login was [REDACTED] which shows a Janet S Boles from 520 Gulf Shore Drive #334 Destin as owner.

After reviewing all the information, I traveled to Freeport Highschool to re-interview [REDACTED] and [REDACTED].

While speaking with [REDACTED] she reiterated what she previously told me about her knowledge of "[REDACTED]". She also stated the Snapchat account is still active along with a newly discovered TikTok account. [REDACTED] allowed me to view and record the TikTok video of "[REDACTED]", who resembled the previously mentioned [REDACTED]. After speaking with [REDACTED] I spoke with [REDACTED] again to ascertain if "[REDACTED]s" had any more contact with him to which he stated no. I also questioned him on the phone number he provided for [REDACTED] [REDACTED] to which he advised he eventually found out it belonged to [REDACTED]. He advised him and [REDACTED] are not friends in the typical manner but are more of acquaintances.

I began to investigate the TikTok account which [REDACTED] provided, "[REDACTED]" and there was only the one video posted to the account from 2020. I began to research into [REDACTED] and located a TikTok account, [REDACTED], for her and on her page was the same video posted to the [REDACTED] TikTok account and among the comments on [REDACTED] video, [REDACTED] posted a comment inquiring as to if she was coming back to the Seaside area. This video on [REDACTED] TikTok was also from 2020 and was posted days prior to it being posted on the [REDACTED] account.

I further researched [REDACTED] social media accounts and located the Instagram account which placed her in the Seaside area in March 2022. I was able to locate the residence which the picture was taken from, being

127 Blackwater Street, which is the house next door to where the house party occurred.

I was able to make contact with the homeowner's of 127 Blackwater Street, Douglas and Kathryn Timmerman, who advised this house is strictly an investment property and do not live there nor do they know their neighbors. Douglas provided me with his point of contact, Jamie, from Exclusive 30a property management and stated I could have any documentation needed to assist with my investigation. I contacted Jamie and requested information on the renter of the week of March 13th-19th, along with the week of the house party. She stated she would contact me if she is able to release this information without a subpoena.

I have also reached out to [REDACTED] school, The [REDACTED] located in The Woodlands, Texas and spoke with Security Director, Devin Gauthier, who advised he would speak with the board of directors as the school to see if he is able to release the demographics of [REDACTED] without a subpoena.

I have served TikTok with an additional subpoena as well for the account holder information for two of [REDACTED]'s accounts being the "[REDACTED]" and "[REDACTED]". The subpoena was served to TikTok via their online portal, and I was given the confirmation number of 16513045.

I will advise once I hear from TikTok, [REDACTED].
