
On June 18, 2022, I Deputy Raya followed up with this case. I made contact with the victims around 1941 hours at their residence. The victims advised that their daughter added herself to the "week one hickory street '22" and began screenshotting videos of photos of the incident. The victim reported that multiple items were stolen and that she is still working on the affidavit and figuring out all the things that were stolen, to name a few designer handbags, wine, PS5, and Yeezy's, signed memorabilia, and an unknown amount of cash. The victims also provided videos inside the house the morning after the party because the house cleaners had been cleaning for multiple hours when I arrived. Also provided is a screenshot of the Snapchat users in a group called "Watercolor @ 9:00." A video provided by the victim shows two black males boxing with a pair of white boxing gloves. Also provided was a photo of wearing five replica super bowl rings the victim has in the office; and instagram is s and Snapchat A party flyer was also provided; the flyer was posted on either the 13th or 14th the owner did not leave town until Wednesday, and the house had been occupied by a friend of the family from Wednesday until Friday afternoon. I received Snapchat videos from a local; he allowed me to view story from Friday the 17th. The video shows a fight between two white females boxing with white boxing gloves. The video shows a white male walking throughout the home, looking through multiple rooms. At around 2120 hours, I observed the home due to another planned party for the night of the 18th. I observed a dark in color SUV turn off of High St to head west on Blackwater St; when passing 107 Blackwater St, the vehicle slowed down. Then continued to the end of Blackwater St and turned north onto Cove Hollow St. Continuing to drive north until turning east onto Vermillion Way, then turning north on High St, until turning right onto Sand Hill Cir. While on Sand Hill Cir, the vehicle made a complete loop until back at Scrub Oak Cir and turning east onto that road, where I finally got out with the subjects in the vehicle at Scrub Oak Cir and Needlerush Dr. Upon making contact with the driver, advised they were lost trying to find a friends home but also trying to find Publix. When asked about that, she continued stating that they were heading to a friend's house to hang out with "her." uld not provide an address, just that she was going to a friend's house. The two passengers, I did not want to speak and advised they would wait for a lawyer. After asking if would step out of the vehicle to talk with us, she advised that they were going to a house party, but she didn't know where. said she was at work on the 17th and was not at the party the night prior. and were not at the party the night prior either; she advised they were somewhere in "Santa Rosa," when asked if she meant Santa Rosa Beach, she said


