On 06/20/2022 at approximately 1845 hours, I made contact with an anonymous caller via telephone in reference to this case. The caller advised the name of the black male that was boxing shirtless with black shorts and white socks was [REDACTED]. [REDACTED] attended Niceville High School and he was approximately [REDACTED] years old. Caller wasn't very positive about the identity of the shirtless male but advised that [REDACTED] had the same haircut and body. Caller saw the video posted in Twitter and wanted us to be aware. Caller refused to give its name.

On 06/20/2022 at approximately 1950 hours, I made contact with [REDACTED] [REDACTED] [REDACTED] via telephone in reference to this case. [REDACTED] stated the following:

On 06/17/2022 he saw a post on his friend's "[REDACTED]" Snapchat about a party that was going to take place at 107 Backwater Street. [REDACTED] post advised that everyone was invited and that "booze" was going to be provided. [REDACTED] arrived at the location at approximately 2230 hours. [REDACTED] arrived with his friend [REDACTED] and other two juveniles. [REDACTED] remembered being at the theater room when he heard one of the persons screaming "cops". [REDACTED] left the property and traveled back home.

[REDACTED] stated he left the property at approximately 1115 hours. [REDACTED] advised he didn't do any damages on the property, and he didn't know who the owner was.
