On June 1, 2022, I answered a phone call in reference to the residential burglary that occurred at 107 Blackwater Street on June 18, 2022. The caller advised they recognized some of the people in the photos posted in the news.

The two subjects on the phone did not want to identify themselves, but were willing to give their first names; [REDACTED] and [REDACTED]. They stated they did not attend the party, but their mother showed them the news articles and some pictures of the people there and wanted to pass along that information. [REDACTED] and [REDACTED] stated all of the subjects attend Fort Walton Beach High School, and they believe they all live in the Destin area. The callers were unable to provide me any further information about the subjects. This concludes my involvement in this case.
