On June 20th, 2022 I received a call in reference to a follow-up to a residential burglary which occurred on June 17th, 2022.

I made contact with one of the homeowners, Ashley Templeton, who stated her son had been added to the Snapchat group-chat "[REDACTED]". She said they took screenshots of personnel talking about things that were taken from the residence and about who was at the party. Ashley stated one comment made in the group-chat was "What happens if you took a PS4, asking for a friend".

I made contact with [REDACTED], mother of [REDACTED]. [REDACTED] stated [REDACTED] saw a picture of from the party posted on the Sheriff Office's Facebook page and wanted to say she was unaware the house was broken into. She stated she thought it was a rental for the party. Vivian also stated she arrived at the party around 2230 and left shortly after at approximately 2310. The sent a text message to [REDACTED] stating "this is weird, we're leaving". [REDACTED] stated she was unaware of who organized the party, she just received a snapchat from her friend [REDACTED] with a flyer stating "Party. 107 Blackwawter St, Santa Rosa Beach, FL 32459. Friday June 18th. 9pm-whenever. Pop out. Drinks and food will be included". [REDACTED] also identified [REDACTED] as being present at this party.

I made contact with [REDACTED] who stated he was at the party. [REDACTED] stated he saw a picture of him posted on the Sheriff Office's Facebook page of him smoking a cigar in the home theater of the residence. When I examined the picture I asked him who was with him in the picture, [REDACTED] identified the other male as [REDACTED]. He stated he and [REDACTED] were told about the party by [REDACTED]. They stated [REDACTED] sent them a flyer and told them it was her friend's rental home. [REDACTED] stated he was at the party from approximately 2130-2330.

I made contact with [REDACTED]. [REDACTED] called to advise her daughter and girlfriend were also present at the party. [REDACTED] stated her daughter, [REDACTED], and her girlfriend, [REDACTED] were invited to the party by [REDACTED] using a flyer sent on Snapchat. [REDACTED] said [REDACTED] told her she was under the impression the house was a rental and they were allowed to be there.

At the time of this report [REDACTED], [REDACTED], [REDACTED], [REDACTED], and [REDACTED] have not been interviewed.

The pictures of the Snapchat flyers for the party have been uploaded with this supplemental report.
