On January 12th, 2022, I made contact with Sergeant Ruby from the Harris County Precinct 4 Constable's Office in Spring, Texas to follow up with this investigation.

While speaking with Sergeant Ruby, I was requesting assistance with making contact with [REDACTED]'s family at their residence located at [REDACTED], Texas. I was advised he would have his Corporal John Ryan complete this request due to upcoming shift change.

The following day, January 13th, I received a call from Corporal Ryan requesting more information about the incident and ultimately made contact with [REDACTED].

On January 20th, 2023 at approximately 1434 hours, I received a text message from someone introducing themselves as [REDACTED]. I contacted her the following Monday, and arranged a phone call for Tuesday, January 24th.

During our phone call, I advised the conversation was recorded for reporting purposes to which she understood. On the phone with us was who she introduced as her family advisor, [REDACTED] our conversation, I advised the reason for me having the Constables make contact with her and why this investigation has led me to her daughter, [REDACTED] advised the only reason she found out about the incident was due to Corporal Ryan advising of the nature of my investigation. [REDACTED] further stated they have no friends in the Walton County area and would vacation her periodically, which is not false. I informed her of Aspen's likeliness potentially being used in the persona "[REDACTED]" [REDACTED] was not made aware of the name [REDACTED] however, she did make a comment of how this has happened in the past where people would create false [REDACTED] accounts and send negative and or vulgar messages to people, whilst still using [REDACTED] real name.

I advised this was not the case this time, and [REDACTED] and her both agreed to speak with [REDACTED] again to ensure she did not meet anybody during their vacations down here who would have grown an attachment to her identity.

[REDACTED] all agreed to a either a Zoom or Skype call in the future to show which documents I am speaking of, and both understood the names will have to be redacted.
