This responds to your October 5, 2023, FOIA request for a list of all films that the “U.S. Marine Corps has participated in the production of, in any capacity[...] for the year 2022”. Your request was controlled under file number **DON-USMC- 2024-000012**.

We initiated a search of the files maintained by the office of the Marine Corps Communication Directorate, Communication Operations & Entertainment Media, Entertainment Media Liaison Office (EMLO). In an effort to assist you, EMLO created and provided the following list of all films that they supported in 2022:

Ronin 3 (Documentary)  
Mission Impossible 7 (Scripted Feature Film)  
Battlefield Medicine (Television)  
Impossible Repairs 2 (Television)  
This American Land (Television)  
NCIS Hawaii (Television)

We note that you requested a waiver of all fees. Since we have categorized you as an "other requester", you are entitled to two hours of search time and 100 pages of duplication free of charge. In this instance, the applicable fees did not exceed your free entitlement, so there is no charge for processing this request and the issue of a waiver is denied as moot.

Your appeal, if any, should include a copy of your request, this correspondence, and a statement indicating why you believe it should be granted. It must be postmarked or timestamped within 90 calendar days from the date of this letter.
