Synopsis: Joseph George Helmich, date of birth 07/13/1937, died at the Bureau of Prisons facility, Rochester, Minnesota, on 11/26/2002.

Details: Joseph George Helmich died at approximately 6:00 a.m., 11/26/2002, while incarcerated at the Federal Medical Center, Bureau of Prisons, Rochester, Minnesota. Helmich was writing a letter at the time of his death and autopsy showed that he died of a heart attack.

Helmich's file shows that he was convicted in the United States District Court, Jacksonville, Florida, for espionage crimes on behalf of the Russians. Helmich had been a former Army warrant officer in charge of the crypto system.

(U) "Hookshot" is this Bureau's code name for our investigation to identify a member of the United States military who in 1964 and 1965 was acting as an agent of the Soviet intelligence services (SIS). (S)

(U) This Bureau has learned from an extremely sensitive source who has furnished reliable information in the past that the subject at the end of 1964 or in the first months of 1965 was in Vietnam, presumably in the United States Army working in supply. Subject claimed to have access to information on the location and distribution of nuclear weapons. As of January, 1965, his tour in Vietnam was not to exceed ten to twelve months. He still had ten years to serve in the United States military which may imply that he had already served ten years. (S)

At some stage of his military service, subject had been selected for assignment in radio intercept and decoding work. It is not clear whether these were his duties in Vietnam; however, while in Vietnam, he was (S)

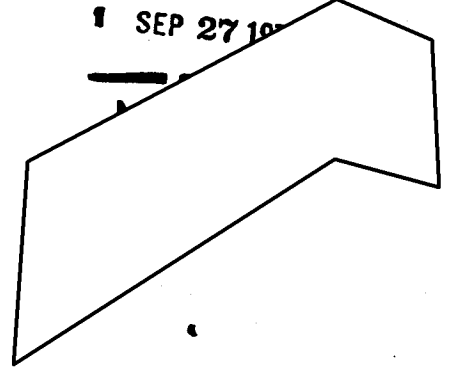

Hookshot is the Bureau code name for our investigation to identify a member of the United States military who in 1964 and 1965 was acting as an agent of the Soviet intelligence services (SIS). The Bureau has learned from [redacted] that an individual who was with a United States Army supply unit in Vietnam during the early part of 1965 was cooperating with the SIS. There is some indication that this individual had access to information on the location and distribution of nuclear weapons. As of January, 1965, the individual was to serve approximately 10 to 12 additional months in Vietnam and had 10 years to serve in the Army to be eligible to retire. (S)

This information was provided to the Assistant Chief of Staff for Intelligence, Department of the Army during February, 1974, with a request for assistance in identifying the Hookshot subject. The Army recently concluded a thorough and discreet review of persons meeting the criteria of Hookshot and have located a possible suspect.

This individual has been identified as Joseph George Helmich, Jr., born July 13, 1937, at Fort Lauderdale, Florida. Helmich was separated from the military during the early part of 1967 and his present whereabouts are unknown to the Army. A recent check with Baltimore Source 4 indicates that Helmich, during the latter part of 1973, was employed by Heritage American, Inc., 1269 Gordon Highway, Augusta, Georgia 30901. He has SSAN 262-46-8727..

NOTE:

(U) Information concerning Hookshot, a developed agent of the SIS during 1964 and 1965, was included in the material furnished by [redacted] during 1972. The original information from the source indicated that the GRU had an agent named "Greenwood" who was possibly assigned in France prior to his posting to Vietnam in 1964. There were indications that at some stage of his military service this individual was selected for assignment in radio interception and decoding work. (S)

[redacted] This information was provided to the Army during February, 1974. They recently advised that Helmich appears to be a logical suspect for the Greenwood agent. Helmich was assigned to various Army units in France during the early 1960's and was assigned to a supply unit in Vietnam during the latter part of 1964 and the early part of 1965. He held a crypto clearance while in the Army until January 29, 1965, when he was denied access to information above confidential. He was intensively investigated by the Army over financial difficulties. Savannah at Augusta is requested to discreetly verify Helmich's current residence and employment, *access to classified material*

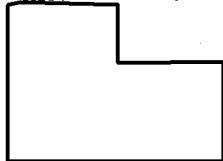

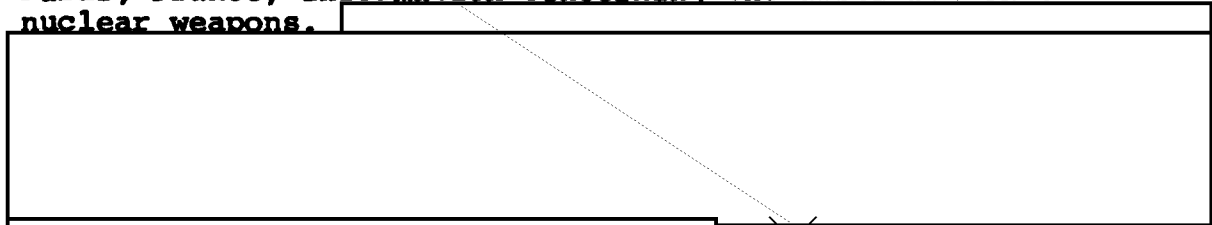

(U) While Helmich is now a civilian with no apparent direct access to classified information, it is believed that due to the information (sigint) he would have been able to provide the SIS in the mid 60's, there is reason to indicate that Helmich could possibly be working for the Soviets presently. In what capacity, we are unable to determine. There presently exists a rather elaborate antenna on the roof of Helmich's residence. In this regard, Helmich resides in a lower class neighborhood. He appears not to be living beyond his means. He is, however, in close proximity to Fort Gordon, Georgia, (a sensitive sigint training facility) and Charleston, South Carolina, (Navy nuclear submarine base).

It is noted that Helmich resigned from the Army, in the fall of 1966 as the Army had begun indebtedness proceedings against him. Helmich seemed to have gone from "rags to riches and back to rags". At the time he left the Army, he was in financial difficulty in that he had many creditors. (S) U

(U) It is realized that Helmich does not appear to be receiving large sums of money, however, if he in fact is still working for the SIS, his motivation may have changed over the years to one of ideology. The ultimate goal in any case, is to interview Helmich (provided he is determined to be Greenwood) in order to gain information for the purpose of making a determination on the following: 1) Prosecution 2) doubling him back against the Soviets and 3) a damage assessment as to any sigint information he may have furnished the SIS. This last factor could have enabled the SIS to intercept and decipher our codes even today. (S)

(U) As Columbia does not have secure telephone communications and a substantial number of FCI trained personnel, it is recommended that FBIHQ Supervisor, [redacted] travel to Columbia for a conference with the SAC, FCI Supervisor and the case officer for the purpose of briefing these individuals on the extensive background of this case as well as to provide direction in discreetly conducting this investigation within distinct parameters. Until it is determined otherwise, this matter is being handled under the assumption that Helmich is presently working for the SIS in some capacity. (S)

In 1972, [redacted] advised that in late 1964 and in 1965 a member of the U. S. Army was acting as an agent of the Soviet intelligence services (SIS). This military man was known to the SIS by code name "Greenwood". There were indications that this individual was assigned in Vietnam and had access to information on the location and distribution of nuclear weapons as he worked in "supply". His tour in Vietnam as of January, 1965, was not to exceed ten to twelve months and he had ten years still to serve before retiring. (S)

FBIHQ is not in possession of further information to indicate what ultimately became of Greenwood. It could be speculated that Greenwood possibly continued to work for the SIS and was directed from another GBU residency, possibly Washington or New York. (S)

(S) [Since receipt of the information in 1972, investigation has been conducted with the U. S. Army to try and identify Greenwood.] The above information was furnished to U. S. Army INSCOR. [The army was able to tentatively identify Joseph George Helmich, Jr. from this information as a likely candidate for Greenwood.] (S)

It is noted that Joseph George Helmich, Jr. was under investigation by the army in 1964 for his "unexplained affluence". On September 2, 1964, the army requested Helmich to undergo a polygraph examination in order to verify Helmich's statements regarding his finances. Helmich ultimately refused to undergo the polygraph examination. (S)

In 1972, [redacted] advised that in late 1964 and in 1965 a member of the U. S. Army was acting as an agent of the Soviet intelligence services (SIS). This military man was known to the SIS by code name "Greenwood". There were indications that this individual was assigned in Vietnam and had access to information on the location and distribution of nuclear weapons as he worked in "supply". His tour in Vietnam as of January, 1965, was not to exceed ten to twelve months and he had ten years still to serve before retiring. (S)

[redacted] as Greenwood was either attempting to get into or was already involved in radio interception and decoding work for the army. (S)

It is believed Greenwood was recruited by the SIS prior to the fall of 1964. The location of this recruitment is not known. [redacted]

FBIHQ is not in possession of further information to indicate what ultimately became of Greenwood. It could be speculated that Greenwood possibly continued to work for the SIS and was directed from another GRU residency, possibly Washington or New York. (S)

Since receipt of the information in 1972, investigation has been conducted with the U. S. Army to try and identify Greenwood. The above information was furnished to U. S. Army INSCOP. The army was able to tentatively identify Joseph George Helmich, Jr. from this information as a likely candidate for Greenwood. (S)

It is noted that Joseph George Helmich, Jr. was under investigation by the army in 1964 for his "unexplained affluence". On September 2, 1964, the army requested Helmich to undergo a polygraph examination in order to verify Helmich's statements regarding his finances. Helmich ultimately refused to undergo the polygraph examination. (S) u
