Please provide a general description of the misconduct. On 10/07/2024, around 9pm the Niagara County Sheriff's arrived at my residence. Shortly upon them arriving, the front door was opened then closed. The door was then re-opened and they told me to come outside. I did, and immediately had my arm twisted behind my back causing severe pain (I was screaming in pain), I was violently taken to the ground, laid upon (could not breath) where I would sustain injuries to my arm, legs and head. Blood was present and visible on my arm and head. The police did not have probable cause or reasonable suspicion to immediately do this to me. I was only told I was being detained, yet was charged with resisting arrest, obstruction of justice, and criminal mischief. They alleged I damaged my mothers property, yet never asked my mom if she owned the property. I have attached a signed affidavit from my mother with photos of my injuries. They came inside our residence without a warrant, probable cause, or exigent circumstances. I was never told Ι was being arrested. I was never read my rights also.
