My sister was involved in a custody case where her kids were essentially stolen by a criminal family who perverted the system with their powerful connections, including the FBI. My brother and I have tried relentlessly to get people to examine the facts of her case to see that her constitutional rights were stripped by the very people that were supposed to protect her and more importantly her children. My sister and her children went into hiding because they had legitimate reasons to fear for their safety. My sister's abuser and his family were abusing her children on visitations and no one was stopping it. There is strong evidence that supports our claims of abuse and a strong history of domestic violence. The police were instructed to not investigate my sister's reports at the direction of Peter Vito, who was not only harassing my sister/family with the use of his private investigating firm, but has terrorized me and my brother for the past several months, as well.

Now my brother is fighting to defend his innocence because he was falsely arrested back in February as a direct result of my sister's custody case for 2nd degree harassment for supposedly tailgating the officer. His car was impounded and towed for a violation, in addition to having a bail set at \$100. I strongly believe the officer wanted access to my brother's phone and car and arresting him was the only way he could do it. My brother has been back and forth 5 times at the Town of Wheatfield Court because he will not accept an ACD. So it is going to trial set for Oct 1st at 4:30 pm. Every attempt to obtain legal counsel to defend my brother has been thwarted. He was finally able to retain one, but that attorney dropped him because my brother would not accept the ACD. If you listen to the conversations, Mike Dwan, does not sound like an attorney working for my brother. My sister's attorney didn't work for her either. Essentially, my sister's abuser and his family have managed to terrorize my family by being above the law and using law enforcement to protect them.

We have been under intense surveillance/harassment since February - military helicopters, CBP helicopters, CPS false reports, spread of lies to neighbors, local shops where we regularly shop (have been told we are kidnappers). There has been no evidence to substantiate or legitimize a search warrant of my home or my mother's home. So how has this been allowed to happen? I surmise by the evidence on misplacedpower.org, Brian Burns (FBI public corruption - Buffalo Field office) is working with Peter Vito in an effort to silence my family and protect the Diarbakerlys. But why?

It is my belief, that the Poloncarz 'suspicious package' was a hoax to prevent the erie county executive from reading our package that was delivered to his office, indicating that Vito, et al. were harassing my family on behalf of the Diarbakerly family. I believe Peter Vito attempted to intercept the delivery of that information and was planning on framing my brother with delivering a dangerous package and/or being a threat to Poloncarz. I believe I thwarted that plan when I called Captain Savage to inquire why his investigators were at my house asking for my brother. Captain Savage said, "How do you know, Kevin didn't threaten anyone while he was at the erie county executive's office? Do you really know your brother? I told him. I

know because he recorded his entire interaction and why on earth would we try to threaten someone we were looking to for help?

No one believes my family because the FBI has painted a picture of us to be the bad guys....the criminal family. How could all of this happen to one family in such a short period of time? I have a suspicion it has to do with powerful people who took a lot of money to make something happen and now that the evidence keeps adding up, it's pointing in the direction of the truth.....my family has been repeatedly victimized by these criminals and no one has stepped up to do the right thing. Thank you for your time. I know if you try to investigate this, you will most likely be harassed or threatened. I ask you this question, who is the FBI working for, if my family is the one being attacked?

Why aren't my sister and her children listed on the FBI website, under parental kidnappings?

Why did it take the Niagara County Sheriff's office months to show an arrest warrant for my sister on their website?

I would think that if this custody case went as legitimately as everyone claims, an Amber alert would have been sent out immediately.

If they are painting my sister as unsafe or unfit, which it sounds to me like they are, then why wasn't any of this addressed or documented during the over year-long court proceedings?

Is anyone wondering who the other voices belong to in the recording of myself, my brother, sister and Brian Burns? Who is pretending to be Kelly Marshal? Who is telling Brian Burns, to tell my brother he did a good job?

Why did the FBI send my brother a response back immediately stating he was not under investigation? (My brother FOIA'd months ago).

Why on earth would Peter Vito and his daughters be allowed to continue to stalk, harass and intimidate me and my family after reporting their criminal behavior back in Nov 2018?

Could it be they are being protected by the FBI, just like the Diarbakerly family? Why was Peter Diarbakerly allowed to come along with Peter Vito and his daughter to my in-laws house? Hi Daniel,

Thank you for the time spent with us this past Friday. I am grateful for any opportunity to share my sister's experience, in addition to our own. I forgot to ask for my flash drive back, as it has family photos on it. I don't mind you saving the videos for your own records. However, my mother-in-law does not want her video shared on air. My in-laws deserve to have their privacy protected. Can I stop by to pick it up sometime this week?

You asked me whose responsibility it was to search for my sister and her kids. At the time, I didn't really have an answer. I think whoever carefully examines the evidence and determines its validity, will also be asking themselves, is there enough proof to demonstrate a reasonable level of fear for someone to leave the only life they ever knew; the only family they truly know and love; the only place they've called home to live a life as a fugitive with two young children. I don't think anyone makes that choice easily and willfully, at least in their own mind or perception.

One thing to keep in mind, every claim made on behalf of the Diarbakerly family came from someone on their payroll with no actual evidence to substantiate the claim, including prepping a 'neutral' supervisor for court testimony. Their attorney even referred to Ms. Kratt as their client.

I'm always astonished at people's reaction to actual evidence. If a few people with authority say it's not true, than everyone agrees it must not be true. As I've said before, lying about or fabricating evidence I would think comes with stiff penalties. We have the most to lose if we are standing behind lies. I know in my heart that the truth will prevail; maybe not in time to save my sister and her children or the rest of my family for standing up for our rights. But, hopefully one day, learning what happened to my family, may prevent something like this from happening again.

Please keep me updated with any information that you uncover. Truth matters to me. Transparency matters to me. Accountability matters to me. I would love for an independent analysis of the recording with Brian Burns and 'Kelly Marshal' to be conducted to verify its authenticity. Furthermore, finding out 'Kelly Marshal's' real identity and the identification of the 'other voice' would give me some peace of mind in all of this chaos.

I continue to pray for my sister and her children and pray even harder for the possibility of their safe return.

I have some questions for you.

You mentioned someone told you my brother turned his back on the judge, yet you said that you spoke to no one in law enforcement. Who gave you that information? Just curious.

I highly doubt that you are doing a piece fairly representing both sides with the Diarbakerly's consent, with Vito's consent, or with the FBI's consent. I also highly doubt that you're doing a piece showing what my family has truly been through.

You know the answer to your question regarding an appeal. If my sister went into hiding before the final decision was made, then how would she appeal it? My sister's affidavit stated she was fearful for her safety and most importantly her children's safety, which was why she felt she had no other choice. My sister's children were being neglected and abused on those visitations and it wasn't a matter of her personal opinion. We all witnessed it and medical professionals documented it. She attached exhibits demonstrating that her right to due process and a fair trial was stripped from her and her children. I ask myself often, if the Diarbakerlys intentionally caused harm in order to scare my sister and make her run. That is a question only they can answer, but even if it was only to produce a certain result, the negative effects on those children are the same.

My sister's attorney requested to be let go, but the judge told him that he couldn't. When her attorney told the judge in court, and on record that I filed a complaint with the judicial committee, he not only betrayed his own client's trust, he shared information with the judge that may have had a retaliatory effect. Any time a judge receives said knowledge, the professional approach should be recusal because at that point impartiality is lost.

Why aren't you giving me answers regarding 'Kelly Marshal'; the lack of and Amber alert; why the FBI has allowed Vito to relentlessly harass me and my family after filing a complaint with the FBI back in Nov 2018? Why haven't you shared with me your reaction to the video of Vito, his daughter and my sister's abuser trying to convince my in-laws to adopt my daughter?

We came to you desperately and genuinely seeking help. Someone on FB reached out to me and asked me, how do I know that my sister's abuser hasn't already found her? I said that I don't know and then started crying thinking about the endless possibilities. Please tell me that you truly want to know what has happened here. Did you copy the CPS letters dated in September to sincerely research them?

I apologize, but I feel that we have been unfairly targeted by not only certain law enforcement, but by the very same people we reported to the highest level of law enforcement and absolutely nothing was done. If people are stalking and purposely intimidating you that does not fall under normal private investigative practices. It also is not appropriate for active border patrol agents to be working as private investigators. So you have verified that the woman speaking in the audio is Kelly Marshal? Did Vito tell you she was real or did you get an official answer? Have you verified the identity of the other person telling Brian Burns to tell my brother he did a good job? I am concerned about the conflict of interests here and feel that more could have been done for my sister and her children to prevent the situation at hand.

And, to have the harassment repeated by not only Vito, but his daughter in front of my home is unacceptable to me and should be to you, as well. If you were to report a co-worker for inappropriate conduct and nothing was done about and then it was allowed to occur again, what would you do?

I have said it before and I will say it again. I am pro-law enforcement, but I do feel when people are in a position of power and they abuse that power, it most definitely should be reported and addressed. I can hand-deliver my sister's affidavit to the front desk at your station, which has medical reports attached, in addition to other pieces of evidence supporting her claims. I also have transcripts which show that she was not allowed to present her witnesses and recordings. My only real concern is that if you are going to do a story, that you are going to present both sides fairly. Family court and CPS corruption is real and the only way it will change is if we examine the evidence to gain deeper insight and understanding. I appreciate you time and attention.
