If you feel that cancellation action is not warranted because of extenuating circumstance, administrative error or other reasons, you must send your State MARS Director a written request for reinstatement within 30 days of receipt of this notification. Members that resign must wait one year before reinstatement. Members terminated for cause must wait two years before being considered for reinstatement. Members terminated for major cause must wait five years before being considered for reinstatement.
