PART J: Explanatory Comments

The National Declassification Center (NDC), Presidential Libraries (LP), and ISOO are the sources of NARA's classification/declassification figures, as in previous years. The NDC facilitates and coordinates the work of other Federal agencies by prioritizing and processing archival records in NARA's custody for declassification. Parts A to D apply only to ISOO. The Director, ISOO, is their Original Classification Authority (OCA) at the TS level. ISOO's numbers include derivative classification actions, and statistics from the declassification reviews that they manage as part of their responsibilities under 32 CFR 2001.36(b) to assist non-governmental archives and individuals properly safeguard classified information outside government control. Part G applies only to the Presidential Libraries processing automatic declassification reviews at NARA. All three NARA organizations process Mandatory Declassification Review (MDR) requests for records in their holdings by consulting with other agency equity holders. No challenges to classification were reported in Part H for FY17 by NARA offices.

The following explains significant differences in figures from those reported in FY16:

Part E: FY17 saw a decrease in the number of MDR cases received, but an increase in number of pages per case. There was also a 28% decrease in the number of MDR cases closed. The most significant drop was at the George H. W. Bush Library due in large part to the library shifting its declassification resources and efforts to equity identification to meet the 25-year automatic declassification provisions of E. O. 13526. Requests taking longer than one year to process is a result of virtually all MDR requests requiring external consultation with one or more agencies. Once we send copies of the documents out for review, decisions are subject to the consulted agency's backlog. Also, dividing very large requests into multiple MDR cases to more efficiently facilitate referrals at the Reagan Library accounts for some of this increase.

Part F: Although the number of MDR appeals decreased slightly, we were able to declassify significantly more pages, with a slight increase in the total number of MDR appeals acted on for FY17, which caused our processing time to increase.

Part G: The significant increases in automatic and systematic declassification reviews, with a corresponding increase in the number of pages declassified under systematic reviews, but with 0 pages declassified under automatic reviews represents, in line 35, the George H. W. Bush Library dedicating more resources to meet the 25-year automatic declassification deadline of December 31, 2018, which resulted in more pages being reviewed. In line 36, the Eisenhower, Kennedy, and Ford Libraries completed processing of all their pending automatic declassification decisions provided to them in FY 2016, but none of the libraries received any decisions in FY17. They expect a large volume of declassification decisions to be delivered in FY18. For lines 37 and 38, the Kennedy Library performed a significant amount of review related to systematic declassification. Their work comprised 76% of the volume of records reported.
