SUBJECT: HPSCI Request for Declassification Review
of Personal History Vignettes

1. Attached are the Personal History Vignettes that Congressman Boland of HPSCI asked CIA to declassify so they could be made public. The Office of Personnel sent them to CRD for an initial review. We have reviewed them and bracketed those portions that we considered classified or protectable under the Director's statutory authority.

[Redacted] When deciding whether information was general enough to be released, we considered the poignancy or power in the particular vignette to carry the message they were intended to make. Thus in some borderline cases, we left in some rather general references to the above excluded categories, because they carried a strong message on the spouse situation.

3. These vignettes are related to DO activities and therefore, as discussed orally, we are forwarding them to you for review coordination. Please add any additional exclusions you wish to the already bracketed portions. We are sending a second copy of the vignettes, if you wish to perform the actual sanitizations.

4. HPSCI is being informed (on 15 February 1984) that the vignettes must be sanitized before they can be released to the public and that this will take some time. While we do not have a specific deadline, we should not delay the review process unnecessarily.

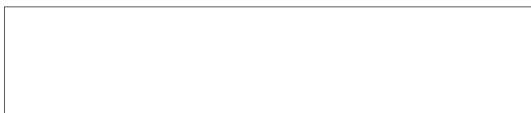
