Details:

The Black Lives Matter movement has applied for, and been granted, a City of Ocala permit to demonstrate on the city square from 1700 hours through 2000 hours, July 17, 2016. In order to fully prepare and monitor all activity surrounding this event, the Ocala Police Department has requested that the FBI assist them by providing intelligence gathered from social media and other open source arenas in advance of the demonstration.

As such, it is requested that this matter be opened and assigned in order to fully document the assistance provided to the Ocala Police Department before, during and after the event.

The matter was initially opened to assist the Ocala Police Department in the collection of social media intelligence concerning the possible disruption of the event. Outside of the original counter protest plans that were noted by the Ocala Police Department on Facebook, no other intelligence was gathered by the FBI and nothing was turned over to the police in advance of, during or after the gathering.

Inasmuch as the event has peacefully taken place and no other similar protests are planned at this time, it is recommended that the captioned matter be closed.
