Dear Alex:

Human Resources is in receipt of documentation supporting your maternity leave request. This is to inform you that you are eligible for twelve (12) weeks under the Family Medical Leave Act (FMLA) annually. In addition, the district has received notice that you have been **approved** for PFML.

Human Resources will be stopping your pay assignment based on the PFML dates for which you have applied in order to eliminate an overpayment from the district. You can begin submitting your claims based on the dates listed below. This is a reminder to plan for the interruption of pay between when the district stops your pay and when you receive your first claim check from Employment Securities Department. Your leave is as follows:

Vacation from 07/06/2021 - 08/10/2021 FMLA /PFML from 8/11/2021 - 10/29/2021. Please provide a copy of your weekly claims reports. PFML bonding from 11/1/2021 - 12/30/2021 Vacation 12/31/2021

Please make sure you enter your absence into the Absence Management System. If you do not have leave accruals during your leave, you remain entitled to take unpaid leave. Please refer to your collective bargaining agreement for additional details surrounding leave usage and return to work.

If you have questions regarding your health insurance coverage, please contact payroll at 253-945-2060. For information on COBRA/Self-Pay, please visit https://www.hca.wa.gov/employee-retiree-benefits/continuation-coverage/sebb-continuation-coverage or contact the HCA at 800-200-1004. You may be required to repay the employer portion of the insurance premium if you decide not to return to work following the leave. Per WAC 182-31-110: If a school employee's monthly premium or applicable premium surcharges remain unpaid for sixty days from the original due date, SEBB benefits may be terminated retroactive to the last date premiums were paid.

You are required to present a release from your physician returning you back to work with no restrictions prior to your return to work. If your release has restrictions, Human Resources need time to make sure it is appropriate for you to be at work and work through the reasonable accommodation process with you. If you need accommodations for pumping upon your return, you need to work with your building principal and office manager for a private location to use before, after and during your planning and/or lunch period.

As a reminder, while on leave, you are not to participate in any additional district-related activities. Please make sure to activate the auto response on your email with the duration of your leave and contact instructions during your absence. Your technology accounts will remain active. Wellness leave shall not be used for activities or responsibilities related to an outside business or engage in other employment.
