We request under the California Public Records Act (CPRA) the following items from the City of Los Angeles (the “local agency” under CPRA). We have made similar requests to various California cities and counties and continue receiving good data about local agency use of electronic communication – and I’d like to thank you if your agency has already participated in the past.

Our original request BC-V502330 is replaced by this request, BC-V502330-v2. We corrected your domains to lapd.online or lacity.org (or any of their subdomains) . All else is the same.

Please provide only those copies of records available **without any fees**. If you determine certain records would require fees, please instead provide the required free notice of which of those records are available and non-exempt for inspection in-person if we so choose. We do not agree to pay any fees automatically by virtue of this request. Please use email to respond. If your agency has subordinate agencies that should handle parts of this request, please forward the request on-ward to appropriate officials.

We remind you of your obligations to provide electronic records in the original format you hold them in. If you choose to convert emails, for example, to PDF format, to easily redact them, you must ensure that you have preserved the full content of the original email record, which contains many detailed headers beyond the generally used From/To/Subject/Sent/etc. For the chat apps, a screenshot or print-out is acceptable. Please review your obligations to provide public records that are on personal accounts/devices per City of San Jose v Superior Court (Smith, real party in interest, 2017). Our requests for public records from

personal accounts excludes former employees.

If you use PDF, use properly redacted searchable or text pdfs. Please don't use image PDFs to make it harder to analyze the records.
