To Whom It May Concern:

Pursuant to the New York Freedom of Information Law, I hereby request the following records:

1. A copy of any policy, guidance, or training concerning N.Y. Elec. Law § 17-130(10), which provides that it is unlawful for any person to "[s]how[] his ballot after it is prepared for voting, to any person so as to reveal the contents, or solicit[] a voter to show the same."

2. A copy of any records concerning any enforcement or attempts to enforce N.Y. Elec. law § 17-130(10) since January 1, 2016.
