

Colorado State Patrol Public Record Request

The Colorado State Patrol allows inspection or release of agency criminal justice records in accordance with established statutory policy and/or guidance from the following Colorado Revised Statutes: Public Records Law §24-72-201, Criminal Justice Records Act §24-72-301, and Children's Code Records and Information Act §19-1-301, as amended. The first hour of staff research time related to fulfilling a record request is free to the requestor. The subsequent review, production and/or redaction of agency criminal justice records that takes more than one hour of staff time, the CSP shall charge \$30.00 an hour. As permitted in §24-72-205(6)(a), C.R.S., for all staff time associated with locating and producing records, the CSP may charge an hourly rate greater than \$30.00 an hour when specialized document production or specialized skills are required to locate, compile or produce records. In addition, if the Record Custodian determines that the research time will extend beyond one hour, a \$50.00 deposit may be required.
