Dear Mr. Ray:

Please accept this letter as the NHCRWA's response to your request for public information, received after business hours on the evening of May 30, 2023 (the "Request"), in which you asked the NHCRWA to provide the following documents:

- "Payroll [r]ecords (salary and hourly employees) for all full-time and part-time NHCRWA staff for fiscal years 2020, 2021, 2022, and year to date for FY 2023.
- "Copy of complete [e]mployment [c]ontract between NHCRWA and General Manager and Deputy General Manager including Jimmy [sic] Schindewolf and June [sic] Chang and any other executive level staff under [e]mployment [c]ontracts between [f]iscal [y]ears 2020 through [c]urrent.
- "Correspondence and emails originating or delivered to the NHCRWA email servers between NHCRWA staff and San Antonio Area Water Systems, [sic] (SAWS).
- "Correspondence and emails originating or delivered to the NHCRWA email servers which make reference to 'Vista Ridge' or 'SAWS' or 'San Antonio Area Water System'.

In addition, the Request instructs the NHCRWA to upload responsive documents to https://www.muckrock.com/respond/1499860/. A copy of the Request is attached.

As you may be aware, the Texas Public Information Act (the "Act") requires the NHCRWA to provide most public information within the NHCRWA's custody or control. However, the Act applies only to information already in existence<sup>2</sup> and does not require the NHCRWA to prepare

new information.<sup>3</sup> In addition, the Act does not require the NHCRWA to prepare answers to questions or to perform research.<sup>4</sup> For information that exists in an electronic medium, the NHCRWA must provide a copy of the information in the medium requested as long as it is not required to purchase any software or hardware and providing the information does not violate the terms of any copyright agreement between the NHCRWA and a third party.<sup>5</sup>

Based on the foregoing requirements, the NHCRWA's duty related to the Request is to identify and provide public information in its custody or control that is responsive to the Request and already in existence, including information existing in an electronic medium, and for electronic information to provide the information in the requested medium as long as the NHCRWA is not required to purchase hardware or software or violate a copyright agreement in so doing.

Pursuant to the Request and in accordance with the Act, attached are copies of the following:

- 1. Earnings History reports for 2020, 2021, 2022 and 2023 year-to-date
- 2. Third Amended and Restated Employment Agreement, dated January 1, 2016, between the NHCRWA and Jimmie Schindewolf
- 3. Employment Agreement, dated January 1, 2021, between NHCRWA and Jun Chang
- 4. Responsive emails between NHCRWA and San Antonio Water Systems ("SAWS")
- 5. Responsive emails referencing "Vista Ridge," "SAWS," or "San Antonio Area Water System"

The NHCRWA believes this information fully responds to your Request. If you sought different or additional information, please let me know.
