Dear ART Bay Area Regional Working Group –

Caltrans, Metropolitan Transportation Commission/Association of Bay Area Governments, Bay Area Regional Collaborative, and San Francisco Bay Conservation and Development Commission are pleased to announce the **release of [Adapting to Rising Tides \(ART\) Bay Area!](#)**

No matter where you live in the Bay Area, **shoreline flooding from sea level rise and storm events will affect how you live.** Driving on highways will be affected by as little as one foot of flooding, halting the commutes of hundreds of thousands of residents and visitors daily. With two feet of flooding, communities will start feeling serious impacts to their homes and jobs. **Rising sea level will fundamentally change our relationships with the Bay**, including threatening our public access to the shoreline and enjoying of shoreline recreation. And, our natural habitats are truly at risk.

But these impacts do not have to happen –some local planning is underway, and we need more, faster, and more coordinated planning to face the full magnitude of impacts. Planning how to adapt is an opportunity to address current issues and future threats.

WHAT IS IT?

ART Bay Area is the first ever regional comparison of the impacts of rising sea level on people, the environment, and the regional systems we rely on. This report provides a better understanding of **where we are vulnerable and lays out a pathway to plan for the future.**

ART Bay Area illuminates potential impacts of flooding to four critical region-wide systems: transportation, future growth areas, natural lands, and vulnerable communities.

HOW DID WE DO IT?

To support the region-wide analysis, we initiated **32 local deep dive studies to deeply understand how these impacts could play out within a community.** These systems and locations were analyzed at a total of ten flood levels ranging from 12" to 108" to show a wide range of impacts over time.

We are grateful for the nearly 600 community members, nonprofit organizations, city and county planners, business representatives, elected officials, and state and federal staff who engaged with us in developing this study over the past three years.

WHY NOW?

The urgency is clear – the impacts of rising sea level will be felt sooner than we previously thought, and even lower levels of flooding will have serious impacts on critical services such as transportation networks and jobs.

The current global health crisis caused by COVID-19 is a reminder that our collective future can be an uncertain one. **Sea level rise is just one of many factors that will influence how we live, work, and engage with our communities and environment in the Bay Area in coming decades – and the cost of inaction is too high.** It may also serve as a reminder of two things: that our society can and will come together for the greater good, and that targeted, coordinated action can create better outcomes for the future. ART Bay Area helps move the region forward in making proactive decisions about how best to manage sea level rise to ensure that our future is safe and resilient.

The Commission held a public hearing on proposed amendments to its regulations governing enforcement procedures that are codified at Title 14 of the California Code of Regulations, Division 5, Chapter 13, including Appendix H, Appendix I, and a new Appendix J setting forth an Administrative Civil Penalty Policy. Requesting a Stay of Eviction : An Open letter - February 14 2021
We the people who presently reside at Union Point Park, continue to do
so despite the City of Oakland's efforts to remove us in compliance with
your cease and desist order. Our resistance, supported by compassionate
and thoughtful members of our community, is not one of blind defiance,
but rather an expression of our sincere desire to better ourselves and
our city. Surely we could set up tents elsewhere and carry with us the
disarray that is evident when one visits the north end of the park.
There are numerous sidewalks, onramps, and contaminated vacant lots in
the vicinity that could host us individually or in small groups. Perhaps
that would put us outside the BCDC's jurisdiction or the watchful eye of
Harbormaster Brock. But it is likely we would end up in places that both
parties would still consider a nuisance and we would be far less safe,
exposed to high speed traffic or other neighbors who might be hostile to
our presence.
We seek a resolution that benefits everyone involved. A solution that

We seek a resolution that benefits everyone involved. A resolution that addresses the unsanitary living conditions and unsightly appearances; the propagation of crime and the stagnation of our lives; animosity towards our community and the enforcement of law by the city. The administrators of Oakland did abide by their own rules and offered an alternative housing opportunity we refer to as the "tough sheds." This consists of a roughly 10'x12' structure with two windows, two 5v USB ports for power, and two people per unit. There are restrictions on access, limited visitation, no food preparation area, no storage area, no 120v outlets, in other words: no freedom. We find this arrangement to be fundamentally unamerican, unacceptable, and unsustainable costing the city 4.5 million dollars to operate the community cabin program for just 18 months. This is the antithesis of a solution as that cost doesn't even cover all construction and materials; the vast majority of these funds pay for staff and administration costs; not a single dollar of that goes to helping the homeless long term. At best this is a gross misallocation of funds, if not outright corruption; merely a ploy to fill the pockets of insiders.

We, the occupants of Union Point Park and our partners with the United Front Against Displacement, propose an alternative that on the surface may appear similar to community cabins but is actually a long term solution that will allow us to thrive and contribute in a positive way to the local community. We have identified a suitable site, and are already working with the city administrator's office to draft a master plan based on self-governance, structured solutions to living, storage, and communal spaces, Sustainability through job creation and creative fundraising, and integration of the unique artistic culture that exists in oakland to create a place we all can be proud to have in our city. So, in conclusion, we ask the BCDC to support our efforts by extending the deadline to vacate

Union Point Park to March 12. In doing so you will be taking action true to your namesake, in that our well being will be conserved, and our livelihood will be developed. For this we thank you ahead of time and invite you in the coming months, to contribute to the formal establishment of our collective as a 501.c3 non-profit entity.

In any case, please be advised that the FPPC may impose monetary penalties on you personally for filing late -- below is copied from the FPPC's Form 700 FAQs (available on its website):

Enforcement Question

Q. What is the penalty for not filing the Form 700 on time or not reporting all required economic interests?

A. A late fine of \$10 per day up to a maximum of \$100 may be assessed. In addition, if a matter is referred to the FPPC's Enforcement Division for failure to file or failure to include all required economic interests, the fine may be substantially higher. If an individual does not pay a fine, the matter may be referred to the Franchise Tax Board for collection.

Rising seas threaten Bay Area economy, infrastructure, environment, says most detailed study yet

A 48-inch increase in the bay's water level in coming decades could cause more than 100,000 Bay Area jobs to be relocated. Nearly 30,000 lower-income residents might be displaced, and 68,000 acres of ecologically valuable shoreline habitat could be lost.

These are among the findings in the most detailed study yet on how sea level rise could alter the Bay Area. The newly released, 700-page official report argues that without a far-sighted, nine-county response, the region's economic and transportation systems could be undermined along with the environment.

The study by a consortium of state and local agencies concedes that "the findings in this report may cause some alarm." But it argues that coordinated action is needed [sooner rather than later](#) — unlike how the Bay Area neglected its housing needs for decades, creating today's high rents and mortgages that are driving lower-income residents out of the region.

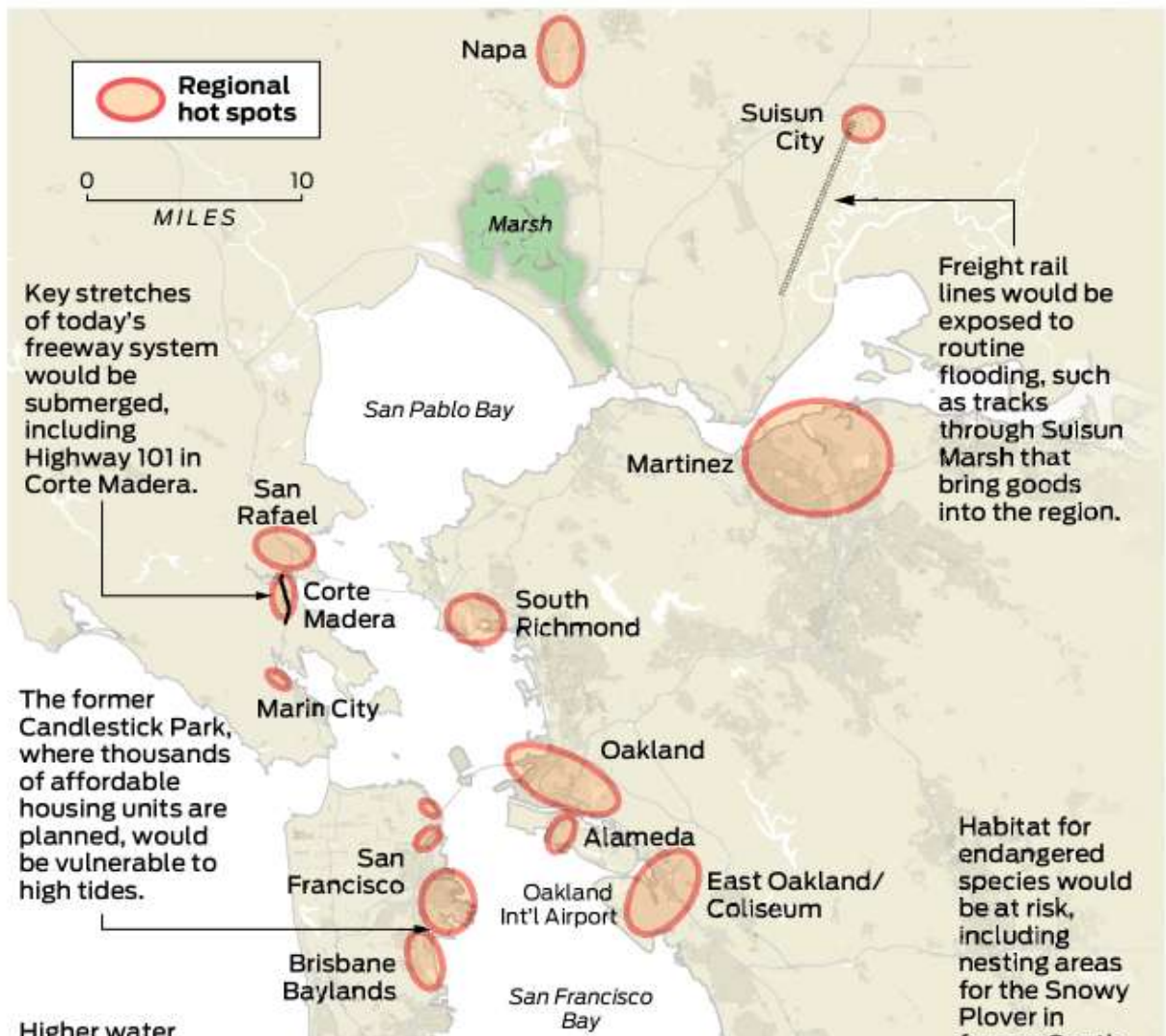
"The Bay Area is at a tipping point, poised between a growing body of information ... and the beginnings of irreversible impacts," the report states. "We know that rising sea levels are coming. And we know what the potential impacts will be."

The study was led by the Bay Conservation and Development Commission, which released its [first detailed look](#) at sea level rise in 2007. But the autonomous state agency was joined in this effort by the Metropolitan Transportation Commission and the Bay Area Regional Collaborative. Caltrans funded most of the \$1.2 million study, which bears the unwieldy title, [“Adapting to Rising Tides Bay Area: Regional Sea Level Rise Vulnerability and Adaptation Study.”](#)

This coordination signals that the impacts of climate change will go beyond ecological ones, say the creators.

Sea level rise hits home

A new government report studies the possible impact of sea level rise on the Bay Area's environment, economy, transportation networks and social diversity. It also identifies 18 “regional hot spots” that would be affected in multiple ways. This map shows examples of the impacts that would be felt with water levels 48 inches higher than today, an increase that experts suggest could arrive anywhere from 2060 to 2120.





“You can’t just focus on one piece,” said Zack Wasserman, who chairs the BCDC. “The challenges are huge — physically in terms of how we can adapt and governmentally in terms of whether the region can come together” to tackle a threat still seen as in the distance.

The full report analyzes scenarios for 10 different extremes of “total water levels,” a term that would apply to straightforward higher tides — day in and day out — as well as storm surges layered on top of higher tides. They range from 12 to 108 inches.

But much of the emphasis is on a raised water level of 48 inches, a number that corresponds to the “likely” amount of sea level rise forecast in the Bay Area for 2120 by the California Ocean Protection Council. More ominously, it’s an average level that could arrive as early as 2060 under the council’s “highest risk and least likely” model.

Each scenario is viewed through four filters: the impact on natural habitats, transportation networks, areas where new development is planned and “vulnerable communities” that, for instance, live in older, low-lying neighborhoods of Richmond and San Rafael.

The findings go beyond large-scale numbers to highlight specific aspects of the approaching threat to how the region functions.

- The access points to four major bridges would be affected, including the Bay Bridge in Oakland and both sides of the Dumbarton Bridge at the south end of the bay.
- Runways at San Francisco and Oakland airports would be largely under water.
- Nearly 31,000 jobs planned for north San Jose would need to be relocated

Nearly 51,000 jobs planned for North San Jose would need to be relocated.

- Cropland that now generates more than \$15 million in annual revenue for local farmers could be lost.
- At least 78 miles of protected bicycle trails, most of them fairly new, would often be off-limits.

“All these different aspects of the region are interconnected,” said Dana Brechwald, who oversaw the study’s preparation. “The solutions aren’t going to be one size fits all.”

In a place with as many competing interest groups as the Bay Area — and a political process that allows those groups the opportunity to weigh in at multiple points along the way — there’s no guarantee that a guaranteed response will be easy

The report acknowledges this, discreetly.

One example is the way that recreational treasures such as paths through restored marshes, or playing fields near the shore, must be balanced against the need to provide protected habitats for endangered and fragile species as waters rise: “Different stakeholders may have differing priorities,” it concedes, “for the management of natural shoreline areas that prioritize people, natural systems, or flood control ... over one another.”

Similarly, many low-lying areas along the bay have been defined in past regional planning as “priority development areas.” Nearly 30,000 housing units have been approved along San Francisco’s shoreline alone. These proposals include elevation of the existing sites by as much as 10 feet, but many environmental advocates say any new construction would be foolish.

The report, however, suggests that as the region moves forward to craft adaptation strategies for sea level rise, “We can’t let perfect solutions be the enemy of workable and fair ones,” that address other Bay Area needs.

The report has been in the works since 2017 and the original goal was to release it several months ago. Instead, it went online without fanfare last Thursday.

The reason for the muted release? The Bay Area’s shelter-in-place order that has been imposed through May 1 to try and contain the spread of the coronavirus — a fresh example of how present-day crises inevitably take precedence over long-term threats.

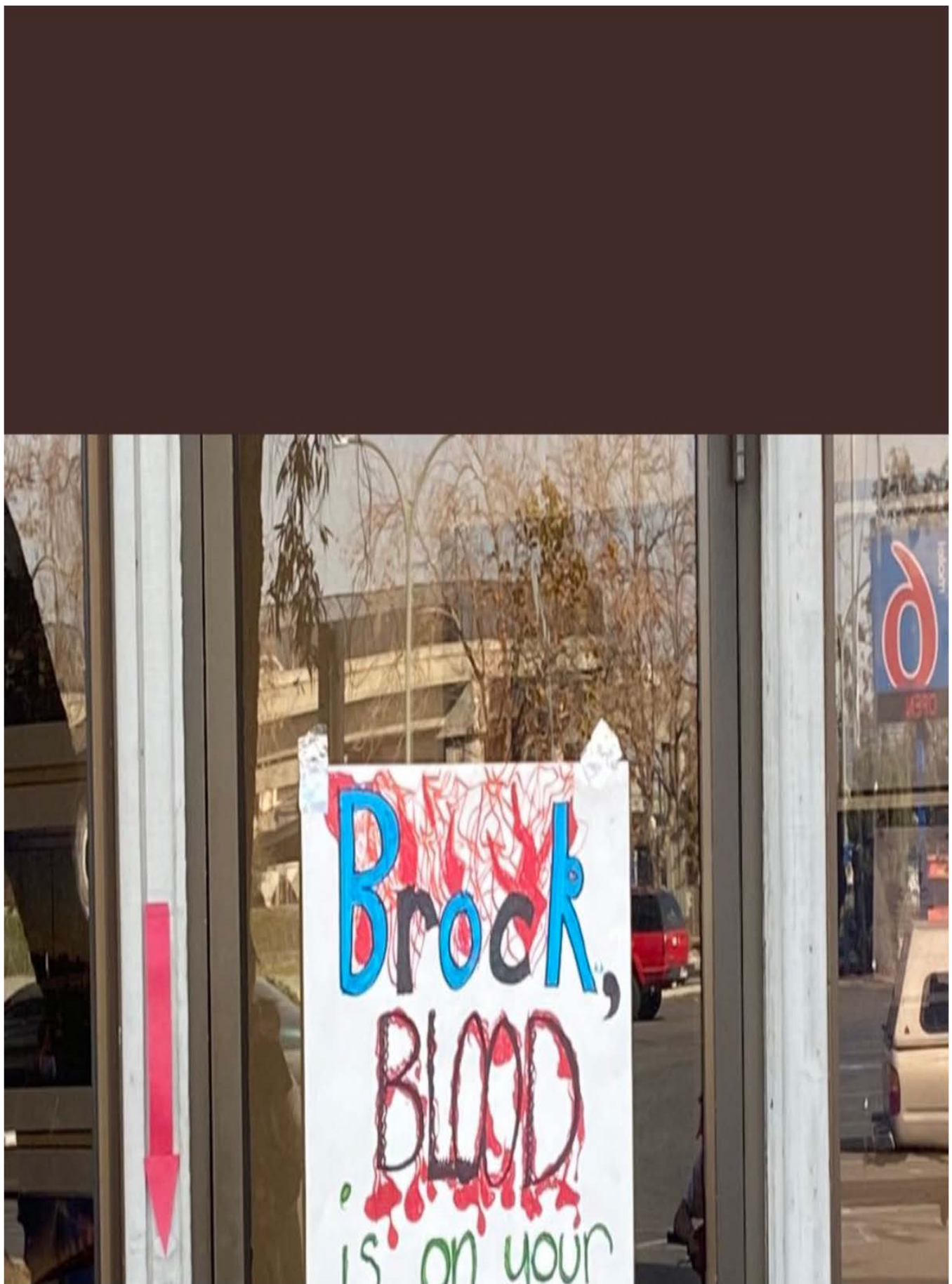

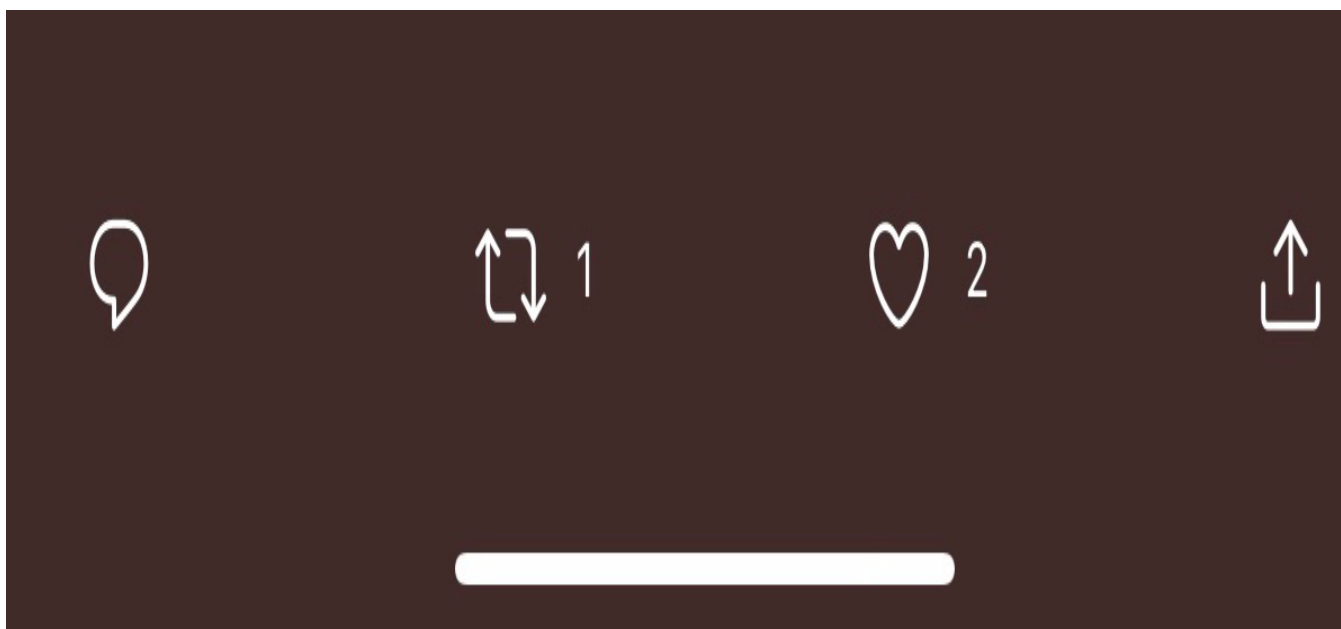

Early yesterday afternoon, Supervisor Gioia called to let me know that Contra Costa County and various state and federal officials had decided that the Craneway Pavilion in Richmond should be used as a COVID-19 medical facility and, therefore, that the Bay Trail segment along that portion of the Richmond waterfront needed to be closed off. I told him that BCDC fully understood that need, and that we would require appropriate signage to be placed where the Bay Trail would be cut off.

To make a short story even shorter, I immediately connected Ethan with the county and Craneway officials, they agreed on a plan today, and Andrea created signs that include both an explanation of the closure and, as I requested of the county, a map explaining how to move safely around the closed area and reconnect to the Bay Trail. We expect the fencing and the signs to be in place tomorrow. Indeed, John sent an e-mail to his Contra Costa constituent list early this afternoon announcing the transformation.

I want to thank Ethan and Andrea for working quickly to adapt to this changing situation – it's exactly how government should work. And, I thanked John for calling me during his initial meeting at the Craneway while discussing how the transformation would be made. That allowed BCDC to work ahead of the curve.

Ethan is starting to keep track of the portions of the Bay Trail that are closed due to COVID-19. So far they appear to be somewhat few and far between, and we'll keep folks posted on what we find out.

DESCRIPTION

Implementing climate change adaptation projects to protect the wetlands, habitat

and community infrastructure in the San Francisco Bay region requires new and more funding and financing. The San Francisco Bay Regional Water Quality Control Board (SF Bay Water Board) and the San Francisco Bay Conservation and Development Commission (BCDC) are holding a joint workshop that will explore the financing of climate change adaptation projects that rely on nature-based solutions.

This workshop will bring together “financers” (or providers of financing mechanisms) with “customers” (or potential implementers of adaptation projects) to share information and advance dialogue about financing pathways to implement projects.

The SF Bay Water Board and BCDC encourage projects that protect critical habitats, fish, wildlife and other aquatic organisms and connections between coastal habitats. We are aligning our programs to support activities that can increase natural resilience, such as restoring tidal wetlands, living shorelines, and related habitats; managing sediment for marsh accretion and natural flood protection; and maintaining upland buffer areas around tidal wetlands. The SF Bay Water Board proposes to develop an amendment to the Water Quality Control Plan for the San Francisco Bay Basin (Basin Plan) to address the threats posed by climate change maximizing the use of nature-based solutions (often called “green infrastructure”) to protect vulnerable shorelines from sea level rise. BCDC recently adopted new policies in the San Francisco Bay Plan (Bay Plan) to allow large-scale fill in the Bay to create and bolster natural habitats and, for the past three years, has convened a working group comprised of BCDC Commissioners, financing experts and other stakeholders to analyze a wide variety of financing options for multi-benefit habitat projects. This workshop builds on the discussions and knowledge sharing generated by the working group.

Please join us on Wednesday, July 8, 9 am-noon, in our Zoom Virtual Meeting. Presenters will include financing experts from the State Water Resources Control Board’s Division of Financial Assistance, the California Infrastructure and Economic Development Bank (iBank), and land and facility owners and operators developing shoreline protection strategies such as East Bay Regional Park District, East Bay Dischargers Authority (EBDA) and Coastal Hazards Adaptation Resiliency Group (CHARG, an initiative of the Bay Area Flood Protection Agencies Association).

FPPC to extend Form 700 deadline due to COVID-19

Due to the current COVID-19 pandemic, the Fair Political Practices Commission is allowing a 60-

Due to the current COVID-19 pandemic, the Fair Political Practices Commission is allowing a 60-day extension until June 1, 2020 for those required to file a 2019 annual Statement of Economic Interests (Form 700). This two-month extension means Form 700's that are normally due on April 1, 2020 will be accepted by the Commission as timely until June first. The extension will apply to all officials required to file in April pursuant to Commission Regulations 18723 and 18730. The Commission intends to formally ratify this extension at its April 2 special meeting.

"We recognize the unique and serious nature of this pandemic and its effects on the public, as well as the work and effort now demanded of public officials around the State," said FPPC Chair Richard C. Miadich. "We don't want to place undue burdens on people when their and all of our primary efforts should be to help California get through this pandemic."

The FPPC still encourage filers to file when they can, as soon as they are able. Those who have access to an electronic Form 700 filing system are encouraged to take advantage of its use. If electronic filing is not available, filers can submit Form 700's by mail. Statements postmarked on or before the new, extended deadline will be considered filed on time.

"I'm proud of how Californians are responding to the calls by our public health and elected officials to do their part in helping us all get through the COVID-19 pandemic," said Miadich. "Form 700's are vital and necessary for transparency among our public officials and are still required. But these extenuating circumstances require flexibility, and that's what we're trying to achieve."

The Fair Political Practices Commission's advice telephone line is closed until further notice. The FPPC will, however, continue to timely respond to requests for advice received via email. If you have an advice question related to Form 700 filing, please send your question to Form700@fppc.ca.gov. If you do not have access to email you may call 916-322-1052 and leave a message, however responses from that line may be delayed.

Commissioners, Alternates, and Staff,

As you all know, I have served as Acting Executive Director for the past 3 weeks while Larry was out on medical leave. Starting tomorrow, Larry will return to work full-time. Before I pass the conn back to Larry, I would like to give you a brief update on where we stand in our response to COVID-19.

Over the past week and a half, the BCDC staff have been continually adapting to the situation presented by the spreading virus. The changes that we have made at BCDC are based on evolving guidance from Governor Gavin Newsom, CA Natural Resources Agency Secretary Wade Crowfoot, and the San Francisco Department of Public Health. Fortunately, the line of communication between the parties has been wide open, which has help tremendously.

We have and will continue to revise BCDC's operational procedures as needed. Here are two short summaries of changes made to date:

- 1. BCDC Public Meetings.** We cancelled the March 19th BCDC Commission meeting and the March 25th BCDC Enforcement Committee meeting. At this time, we expect to adhere to future meeting schedules. We are currently determining how best to hold future public meetings, and are exploring online conferencing tools that allow BCDC meetings to include remote participation by Commissioners, staff, and the public. As part of that exercise, BCDC is committed to maintaining public participation at its meetings and perhaps expanding it.
- 2. BCDC Virtual Office and Staff Telework.** The State guidance and the San Francisco Department of Public Health explicitly recommend enhanced telework schedules. Effective yesterday, March 16, 2020, we have instituted a "virtual office" and, except for a very limited number of staff who occasionally

need to carry out essential tasks at the Metro Center, most BCDC staff are teleworking remotely until such time that state and local authorities deem it safe for BCDC's physical office to re-open. In addition to email and telephone, the staff is using online meeting tools, such as Microsoft Teams and WebEx to continue to meet with each other and the public.

More updates will certainly be coming your way in the days and weeks ahead. If you have any questions along the way, feel free to reach out to us.

And, finally, I'd like to thank the entire BCDC staff for its flexibility, professionalism, and support over the past three weeks as we worked through issues large and small.
