1. DATES COVERED

January 1, 2020-December 31, 2020

2. HOW DATA IS COLLECTED/RECOVERED:

The department documents personnel complaints in PS Net. PS Net is the department's RMS that stores data from investigations of complaints and personnel and can generate reports based on this data.

3. WHAT DETERMINES WHEN A COMPLAINT IS DOCUMENTED?

Supervisors initiate complaints by generating a Professional Standards (PS) report in PS Net. PS investigations are conducted by supervisors, managers or outside agency investigators. Findings are determined and approved by command staff. The results are forwarded to the Professional Standards Division for final review. There are three sources of complaints; Internal, Citizen Identified and Third Party. Depending on circumstances, supervisors and managers may handle some complaints informally or as a minor formal complaints per BPD Policy Manual 1010.6.2.

4. NUMBER OF PERSONNEL COMPLAINTS FILED FOR 2018:

SUMMARY OF COMPLAINTS

Complaints are divided into two categories; Internal Affairs (IA) Investigations and Citizen Concerns.

Internal Affairs Investigation means a complaint alleges a policy violation and further investigations will be conducted to determine disposition.

Citizen Concern means a person makes a complaint against an employee but no allegation can be determined and no further investigation will be completed.

Dispositions describe if the allegation occurred and fall into four categories: Exonerated, Unfounded, Sustained or Not Sustained.

Exonerated -when the investigation discloses that the alleged act occurred but that the act was justified, lawful and/or proper.

Unfounded -when the investigation discloses that the alleged acts did not occur or did not involve department members. Complaints that are determined to be frivolous will fall within the classification of unfounded.

Sustained -when the investigation discloses sufficient evidence to establish that the act occurred and that it constituted misconduct

Not Sustained - when the investigation discloses that there is insufficient evidence to sustain the complaint or fully exonerate the member

Policy Issue - when everything in the complaint is determined to be accurate, including the member's actions, but the issue appears to require a modification of policy the finding for the member should be exonerated. The need for potential policy modification shall be immediately directed to the Chief of Police for action.

The 36 Allegations in 2020 were placed into eleven different categories; Laws, rules and orders, safety, intoxicants, ethics, discrimination, relationships, attendance, unauthorized access, efficiency, performance and conduct. The table below shows the total number of allegations per category and the disposition for each category. For example, 10 allegations were categorized as “Laws, rules and orders”. The investigations of these allegations determined one allegation was unfounded, ten sustained and two not sustained.
