Dear FOIA Coordinator Kim Siegel:

On September 21, 2018, I filed a public information request by email under the Delaware Freedom of Information Act,¹ seeking:

A current snapshot of the Microsoft Access or Microsoft SQL database(s) ("the database") forming the backend of the Delaware Criminal Justice Information System's ("DeIJIS") Online Wanted Person Review ("OWPR"; url: https://pubsrv.deljis.delaware.gov/WantedPublic/).

This request is enclosed with this letter.²

I filed this request on September 21, 2018 with DeIJIS. The request was again directed to the attention of Earl McCloskey, the DeIJIS FOIA coordinator, on September 28, 2018 by Peggy Bell, a planner at DeIJIS, and by myself again on October 22, 2018. An agency shall provide a response to a request, either in the form of a denial, the requested records, or advising that

additional time is required to respond.³ The period since I filed my request greatly exceeds fifteen business days. I seek to have the Attorney General:

- 1. Enjoin DelJIS to provide a response to my request; and,
- 2. Enjoin DelJIS to provide the requested database snapshot.

While it in no way discharges his statutory duty under FOIA, on September 5, 2018, Earl M. McCloskey, Executive Director of DelJIS, sent me a formal letter of denial in response to a different, previous request for "[d]atabase entries from the [DelJIS] Online Wanted Person Review available during June, 2018."⁴ In response to my request, Mr. McCloskey claimed that the records I am seeking "do not exist and are not in a static file."

I wish to note three points in particular:

- 1. The requested records do, in fact, exist;
- 2. The requested records are public, both by virtue of the statute specifically designating them as a public record and by DelJIS's own practice of publishing them; and,
- 3. There is no exception under FOIA for records which are "not static."

With respect to the existence of the records (hereafter "the database"), we know the database exists because DeIJIS publishes entries from it, while current, on a public facing website, the DeIJIS Online Wanted Person Review.⁵ The Wanted Person Review, moreover, makes use of standard Microsoft web and database infrastructure to query a backend database which provides the wanted individuals displayed on the results page.

As for the public nature of the records, all records are presumptively public information under FOIA, including electronic information and databases.

The definition of "public record" under FOIA is very broad. It includes all information contained in or on physical documents (typically paper), as well as information stored in electronic format (such as Word, Excel, etc.) or databases, relating in any way to public business, or in any way of public interest, or in any way related to public purposes. Thus, as a practical matter, FOIA's concept of "public record" covers, at least initially, almost every conceivable type of physical or electronic record that may be created, maintained or possessed by a public body.⁶

A fortiori, records which an agency actually publishes and labels public information, as evidenced by the "WantedPublic" language contained in the URL above, are public information. Moreover, as I have noted in my requests to DeIJIS, I am seeking is not investigatory in nature.⁷ Neither does it contain or constitute any information exempt from public disclosure under FOIA's exception for criminal history information,⁸ a provision from which the requested information is specifically exempted.⁹ Furthermore, the Delaware Superior and Supreme Courts have held that information contained in DeIJIS databases that is not criminal history information is subject to disclosure.¹⁰

Lastly, there is no exception under FOIA for records which are not static or "not in a static file." The right under FOIA to access current versions of public records which may be updated or revised in the future, such as call logs,¹¹ calendars¹², and "real-time" spreadsheets inventorying equipment belonging to state agencies,¹³ has repeatedly been recognized.

Additionally, we are seeking these records in their most basic form; in any spreadsheet, plain text, or comma separated value format exported directly from the database maintained by DeIJIS. In addition to the claim that these records do not exist, Mr. McClosky also cited, notes that a public body is not required to compile information from various sources to create a document or provide information in a question-and-answer format.¹⁴ To reiterate, the records we are seeking do exist. Moreover, because we are seeking these records in their most basic, native database format, no additional document creation is required at any point. This data can be generated easily, even for large spans of time and potentially thousands, or even hundreds of thousands, of entries. A database export of this nature requires no document creation, photocopying, multi-source compiling, or drafting.

A government body in receipt of a request "shall make every reasonable effort to assist the requesting party in identifying the records being sought."¹⁵ Given that Mr. McCloskey's denial was received the same day as he noted he received the request and that the records in question clearly do exist, we have reason to believe that Mr. McCloskey did not make every reasonable effort to identify the sought records. Additionally, given this short time frame and the inaccurate nature of the denial and the fact that the public body made no contact prior to the

denial, it is unclear whether a FOIA coordinator worked to "foster cooperation between the public pody and the requesting party" as required by state law.

This complaint is being made in writing, contains a copy of the original request,¹⁶ a sample from DeIJIS proving the existence of the records we seek,¹⁷ and all current correspondence with DeIJIS.¹⁸

We look forward to receiving your decision on this matter.
