Property manager called dispatch to complain that two motorcycles were on the property. Upon arrival I spoke with the property manager who advised that he had spoke with them and told them to leave that the police were on their way. He described them as an older gentleman with a beard and bald head, no helmet, driving a Harley Davidson type motorcycle with a possible NH Reg of X6133, and a younger gentleman on a green sport bike. I could see motorcycle tracks that had clearly gone around the gate on the driveway. I advised him that he may want to put a barrier at the end of the driveway by the main road to deter people from driving up to the gate and to do something to block the sides of the gates to prevent motorcyles from driving around, I could see large rocks stacked on one side of the gate and then noticed that the rocks on the other side had appeared to have been moved, which he confirmed.
