Dear Requester:

On 14 September 2021, the Office of the Information and Privacy Coordinator received your 1 September 2021 correspondence seeking to appeal the 21 May 2021 response you received regarding your Privacy Act request submitted electronically on 8 January 2021.

As stated in our 21 May 2021 correspondence, this office is unable to accept Privacy Act requests submitted electronically due to privacy concerns; you may not appeal this response. However, you may submit a new Privacy Act request containing the required information. Please note that the Privacy Act requires federal agencies to safeguard personally identifiable information about an individual. CIA's Privacy Regulations, Title 32 C.F.R. § 1901.13, establish the criteria below:

An individual seeking access to or amendment of records about himself shall provide in the letter of request his full (legal) name, address, date and place of birth, and current citizenship status together with a statement that such information is true under penalty of perjury or a notarized statement swearing to or affirming his identity. In the case of an individual who is an alien lawfully admitted for permanent residence, said individual shall provide his or her alien registration number and the date that status was acquired.
