On Wednesday, September 25th, 2019, I was acting as (b) (6), (b) (7)(C) at the Shasta Dam Security Office, Post 714. On my arrival at 1440hrs I observed a large group, which I estimated to be approximately 40 or more individuals, associated with "Run4Salmon" congregated on the lawn near the east abutment door. They were behaving peacefully. At approximately 1608hrs I received a call from (b) (6), (b) (7)(C) in Post 1950 advising me that (b) (6), (b) (7)(C) had called to advise that the group had entered the Visitors Center and (b) (6), (b) (7)(C) wanted additional security personnel to respond. I immediately went to the Visitors Center and saw the crowd surrounding the Guide Desk. I made contact with (b) (6), (b) (7)(C) who was posted there and repositioned (b) (6), (b) (7)(C) to be more visible and then went to get direction from (b) (6), (b) (7)(C). (b) (6), (b) (7)(C) told me that the employees were uncomfortable with the group's presence and the immediate goal was to get them to leave. I then contacted (b) (6), (b) (7)(C) and (b) (6), (b) (7)(C). I then returned to talk to the group and quietly explained their presence was a source of concern and we would need to get them to leave. The group remained noncompliant until at 1650hrs (b) (6), (b) (7)(C) (b) (6), (b) (7)(C) told them (b) (6), (b) (7)(C) was locking the front door and they needed to leave by the north door. They did, congregating at the picnic table. At 1655 (b) (6), (b) (7)(C) arrived onsite. (b) (6), (b) (7)(C) addressed the group telling them that they were making the employees uncomfortable and with such a large group that a permit was required and lastly that they needed to leave. Several of the group reacted angrily and directed their anger towards (b) (6), (b) (7)(C). At this point, 1657hrs, I contacted Shascom and they said a deputy would be enroute. I then spoke to some of the apparent leaders and advised them they needed to leave. At 1715hrs the group started to leave the site as Shascom called me back, saying the deputy was 7-10 minutes out. I advised them that the group was leaving and I would call back if we had any further issues. At 1725 the group of 40 or more protesters had driven off site.

NARRATIVE:

On September 25th 2019 I was working as an Armed Guard at Post 705 Visitor Center for Chenega Security International California. At approximately 1000hrs A group who identified themselves as Run4Salmon started to gather by the east picnic area near the Visitor Center. A few of the individuals entered the Visitor's Center but caused no major issues. I did have contact with a couple of the group to not to leave their backpacks or cellphones unattended. One WFA approximately mid20s was warned more than once she got an attitude but complied. At approximately 1610hrs I was walking to north single door entrance to Visitor Center because I noticed the crowd outside had moved and wanted to keep track of them. They had circled to the main entrance and entered the building. They surrounded the Tour Guides/information Desk and were speaking with the tour Guides. When I approached they started pointing a video recorder at me so I posted myself were the person with the camera could not get a clear shot of me but still monitor the situation. They then started to chant/sing I moved away to radio for assistants when I saw the **(b) (6), (b) (7)(C)** approaching. **(b) (6), (b) (7)(C)** came in and advised me to be in a more visible position. **(b) (6), (b) (7)(C)** then calmly tried to reason with their leaders. They refused to leave even after being informed the BOR employees they wanted to speak with were not there. I was informed by **(b) (6), (b) (7)(C)** that the **(b) (6), (b) (7)(C)** had been contacted and was on **(b) (6), (b) (7)(C)** way. They blocked the front doorway from allowing people to safely enter or exit the building. At approximately 1640hrs **(b) (6), (b) (7)(C)** told them they had to go and went to the front doors locking them and herding them towards the north door to exit. They started chanting/singing as they left through that door I followed asking the people who lagged behind that the Visitor Center was closing. Then I cleared the bathrooms and movie area.
