2. Employee hereby waives any rights and entitlements he has pursuant to Section 75 of the Civil Service Law and accepts the within discipline in satisfaction of a potential Disciplinary Action for incompetence and/or misconduct.

3. MY DISCIPLINARY ACTION SHALL CONSIST OF THE FOLLOWING:

• Loss of 3 Personal Days

4. Employee freely and voluntarily enters into this Stipulation Agreement. Employee consents and agrees to be bound by its terms and conditions and understands the contents thereof. Employee further understands that he is entitled to be represented by an attorney and hereby waives any such representation.

Attached is a memorandum sent to me by Sgt. Feldman. In the memorandum, Sgt. Feldman describes another incident where P.O. Jackson was observed sleeping during his tour of duty. This incident is alarming considering he was observed sleeping in his car at 0200hrs in an area known for frequent pedestrian traffic during bar closing time.

Sgt. Feldman continues, stating previous discussions with P.O. Jackson regarding sleep habits as well as previous disciplinary actions relating to this same issue. He also forwarded a picture that he took of P.O. Jackson while sleeping in his patrol vehicle.

Since this issue was directly observed by a supervisor as well as it being a continuous course of conduct, I recommend that this incident be forwarded to you for action without the necessity for further investigation by me.

Lt. Ferguson,

On Sunday 2/09/14 at 0200 hrs., I was making regular patrols in the downtown area looking for problems at bar closing time. I pulled off of Bristol Street to check the back of the Pickering Pub and then drove over into the Coach Street side of the parking lot. I saw P/O Jackson's patrol car parked across a few spaces in front of the Bristol Coach Plaza and swung around to check and see how things were going. As I stopped with my passenger side next to his car, I saw that P/O Jackson was sound asleep with his mouth open.

I attempted to wake Jackson by shinning the spot light on him several times but that did not wake him up. I pulled away and turned around so that I was driver's side to driver's side and then used my flashlight to rap on his car window. After I struck his window the fifth time, P/O Jackson woke up startled and wide eyed. He put his window down and I spoke to him. I told him that he had obviously stopped for too long and that he could not be sleeping in the parking lot in front of a bar at bar closing time in full view of the public. He stated, "I know, I will put my window down." I spoke to him for a few more minutes to ensure he was fully awake then continued my patrol.

P/O Jackson and I have had several conversations due to past problems about him unintentionally falling asleep. He has stated that he never stops with the intent to fall asleep but will fall asleep as he is tired from not being able to sleep properly during the day. I advised P/O Jackson that he can combat this problem in two ways with the first being that when he feels as if he is falling asleep, to get out of the car and walk around and check doors on businesses. The second was to come back to the police station, inform me of his location and then take a power nap inside the building where he was out of the eye of the public and in a location that I knew I could find him or call him on the phone. As you are aware, sleeping in the car has been an ongoing issue with P/O Jackson. The problem I believe is created because P/O Jackson does not conform to a true night shift sleep pattern and unlike others is not able to stay awake when tired. I have advised him to speak with his doctor about the issue and follow his doctor's recommendations. I have also suggested that he sleep at the same time each day so that he can develop a sleep pattern for his body to adjust too. These are things that I have done myself at the direction of the sleep specialist that I see. P/O Jackson has seen his doctor about the issue and was at one time given a sleep aid which he stated did not work for him.

The disciplinary actions of the past in relations to P/O Jackson falling asleep in his car do not seem to have had the desired effect. I feel that P/O Jackson either cannot or will not make the needed changes to his lifestyle or behavior to prevent him from falling asleep again while in his car. I feel that the best solution to the problem for both P/O Jackson and the department would be to assign him to a shift that allows him to sleep at night.
