SUBJECT: Letter of Reprimand

This letter is intended to serve as a formal rebuke for your conduct relating to the distribution of a letter dated January 23, 1990 to members of the Canandaigua City Council, the New York State Department of Civil Service, Robert Flavin, and Lipsitz, Green, Fahringer, Roll, Salisbury, and Cambria.

Although your right to circulate a letter in this case is not in question, the inclusion of privileged information concerning the identity of a juvenile taken into custody and related departmental communications are cause for grave concern.

Your distribution of this letter as written was in flagrant disregard of a duly constitutional statute and Department regulations. Your actions in this matter have compromised your stature as a professional law enforcement officer and have jeopardized the professional integrity of the Police Department, both within and outside the community.

In view of the foregoing, you are formally admonished for your conduct in this matter and most emphatically instructed by this letter to never repeat this or any similar conduct as long as you are employed as an officer in this Department. A breach of the contents of this letter will subject you to formal disciplinary action.
