We, the Cecil County Sheriff's Office "CCSO" have received your request for certain records under the Public Information Act, Annotated Code of Maryland, General Provisions Article ("GP"), § 4-101 et seq. In particular, you seek the vendor information, contracts or purchase agreements involving license plate reader technology.

We are reviewing the request to determine if any of the information needs to be redacted and/or withheld pursuant to the Maryland Public Information Act General Provisions "GP" § 4-335:

§4-335. Trade secrets; confidential information.

A custodian shall deny inspection of the part of a public record that contains any of the following information provided by or obtained from any person or governmental unit:

- (1) a trade secret;
- (2) confidential commercial information;
- (3) confidential financial information; or
- (4) confidential geological or geophysical information.

I have corresponded with our vendor and expect that it may take additional time for them to review the documents. Under 4-203(b)(2) it may take additional time to fully respond.
