#### LT,

Ring has a Law Enforcement Portal which only comes with this MOU. Detectives would be able to log into the system to see locations of all Ring Cameras and request footage directly from the owner. Ring will subsidize cost of cameras for our residents as part of program if we agree to engage residents and adopt this platform in outreach efforts.

Conflict is this would duplicate efforts with the Civic Eye – Virtual Block Watch program outreach which will become its own database of local video cameras and detectives can request video footage directly from the owner. Its not limited to just Ring Cameras. Also, something that stood out under PVPD responsibilities was "Make data related to PVPD incidents/call logs available to Ring on a mutually agreed upon basis." Data sharing was a concern in the past when attempting to collaborate further with BlockWatch.org organization.

My impression is we use Civic Eye to promote the video surveillance over the conflicts that could arise from promoting the use of one particular security company and their cameras.

I wanted to send the information over for your review.

Officer McGhee, Attached is the MOU discussed. Full disclosure, we usually provide a demonstration of the Neighbors platform and LE Portal before sending. Many of the questions you're sure to have are addressed during that meeting. That said, I hope this makes sense and I hope you'll feel free to ask any questions on the items that don't.

Ring will be back in Arizona in a few weeks to onboard interested agencies to the Neighbors by Ring Law Enforcement Portal (LE Portal), your access point to the Ring Neighbors platform. Key highlights of the LE Portal include:

- 1. One-click video requests from Ring Neighbors based on date, time and proximity to incident location.
- 2. Ability to view and comment on all uploaded (vetted) video and comments from Neighbors within your jurisdiction.
- 3. Ability to push crime and safety alerts / notifications to Ring Neighbors.

The LE Portal is a sophisticated cloud-based system provided free of charge to law enforcement. The formal onboarding process includes technical, administrative and practical instructions on how to best maximize its effectiveness as an investigative and notification tool. To insure proper use of the LE Platform, we require the following stakeholders to be present during the onboarding process:

**Technical Contact**: A master agency credential will be provided to the department. The PVPD technical administrator (Admin) will be responsible for providing and managing log-in credentials to individual users within the department.

**Social Media Contact**: Ring Neighborhoods is a social sharing site. While our motto of "low frequency, highly relevant content" is accurate, the effectiveness of this engagement will only be as powerful as our combined efforts make it. Ring Neighbors post video content based on suspicious and/or criminal activity inviting Neighbor response. PVPD use of the LE Portal to comment on Neighbor posts and to inform your community of crime alerts/activity is an essential element of our program.

**Public Information Contact**: Prior to activating LE Portal for your agency, Ring will notify our Neighbors that we are working with PVPD. We will work with PVPD to create a mutually acceptable message that is concise, accurate and reflective of the goals of the program. PVPD input and approval on that message is required.

**Detective / Investigative Contact**: Those charged with use of portal will be trained on how to engage in the Neighborhood conversation, how to post crime alerts and how to request video when investigation criminal activity.

**Legal Contact**: Discussion on video technology, evidence preservation, chain of custody, etc., as well as appropriate (approved) language for messaging Ring Neighbors of this engagement.

Let's plan to touch base soon to discuss next steps. I look forward to seeing you again soon and to working with Paradise Valley Police Department to reduce crime in PV.

#### **Program Description**

This program will provide PVPD access to the Ring Neighborhoods platform to communicate with Ring Neighbors and encourage community engagement as we work together to make Paradise Valley neighborhoods safer.

- The Ring Neighborhoods platform is a digital neighborhood watch that both law enforcement and the public can access free of charge by downloading the Ring mobile app (iOS and Android).
- The app allows Ring Neighbors to share and comment on real time crime and safety events in their neighborhood.
- As part of the program, PVPD may:
  - Utilize the critical crime and safety events that are posted in the app by neighbors to assist in law enforcement operations and investigations; and
  - Post information relating to critical incidents and other incidents in the app to keep neighbors informed regarding issues in their neighborhoods.
- In addition, PVPD and Ring may work together to offer subsidized Ring cameras to select parts of Paradise Valley.

#### Responsibilities

#### Ring

- Make the Ring App available to Paradise Valley residents free of charge.
- Donate Ring cameras to PVPD or area of Paradise Valley based on the number of qualifying downloads of the app that result from the program. Each qualifying download will count as \$10 towards these free Ring cameras. Ring will seed the program with an initial donation of ten (10) Ring cameras.
- Make the Ring Neighborhoods portal available to PVPD, free of charge, including support and training for PVPD employees.
- Work with PVPD to obtain data/call logs and publish the relevant incidents in the app based on terms agreed to with PVPD.
- As appropriate, subsidize the purchase of Ring cameras by Paradise Valley residents as part of a formal subsidy program.

#### **PVPD**

Engage the Paradise Valley community with outreach efforts on the platform to encourage

adoption of the platform/app.

- Choose how the free Ring cameras should be distributed. There are two options.
  - Cameras will be donated directly to PVPD. PVPD will in turn distribute these cameras to the community as part of its outreach programs.
  - Ring will directly distribute these cameras to the local community, with input from PVPD.
- Maintain appropriate access controls for PVPD personnel to use the Ring Neighborhood Police portal.
- Make data related to PVPD incidents/call logs available to Ring on a mutually agreed upon basis.
- Have the option, but not obligation, to participate in a subsidized camera program.

#### Term

PVPD's participation in the program shall commence upon PVPD's acceptance of these program terms. Either party may terminate PVPD's participation in the program at any time upon providing written notice to the other party. The Ring Neighborhoods Portal will be available to PVPD by Fall 2018.

#### **Press Release**

The parties shall agree to a joint press release to be mutually agreed upon by the parties.

#### Privacy and Terms of Use

Ring will not provide any customer personal information, including video footage, to PVPD without the prior consent of the owner or a properly issued subpoena or search warrant, as applicable. PVPD agrees not to use the Ring Neighborhoods Police Portal other than as expressly authorized by Ring and other than in connection with bona fide PVPD work. Ring's terms of service and privacy notice, as posted on Ring.com, shall apply to all uses of the Ring app and Neighborhoods Police Portal.

#### Compensation

At no point shall either party receive compensation from each other as a result of this program.

#### Confidentiality

Unless otherwise required by law, PVPD shall keep the terms of this program confidential.

Officer McGhee, Attached is the MOU discussed. Full disclosure, we usually provide a demonstration of the Neighbors platform and LE Portal before sending. Many of the questions you're sure to have are addressed during that meeting. That said, I hope this makes sense and I hope you'll feel free to ask any questions on the items that don't.

Ring will be back in Arizona in a few weeks to onboard interested agencies to the Neighbors by Ring Law Enforcement Portal (LE Portal), your access point to the Ring Neighbors platform. Key highlights of the LE Portal include:

- 1. One-click video requests from Ring Neighbors based on date, time and proximity to incident location.
- 2. Ability to view and comment on all uploaded (vetted) video and comments from Neighbors within your jurisdiction.

3. Ability to push crime and safety alerts / notifications to Ring Neighbors.

The LE Portal is a sophisticated cloud-based system provided free of charge to law enforcement. The formal onboarding process includes technical, administrative and practical instructions on how to best maximize its effectiveness as an investigative and notification tool. To insure proper use of the LE Platform, we require the following stakeholders to be present during the onboarding process:

**Technical Contact**: A master agency credential will be provided to the department. The PVPD technical administrator (Admin) will be responsible for providing and managing log-in credentials to individual users within the department.

**Social Media Contact**: Ring Neighborhoods is a social sharing site. While our motto of "low frequency, highly relevant content" is accurate, the effectiveness of this engagement will only be as powerful as our combined efforts make it. Ring Neighbors post video content based on suspicious and/or criminal activity inviting Neighbor response. PVPD use of the LE Portal to comment on Neighbor posts and to inform your community of crime alerts/activity is an essential element of our program.

**Public Information Contact**: Prior to activating LE Portal for your agency, Ring will notify our Neighbors that we are working with PVPD. We will work with PVPD to create a mutually acceptable message that is concise, accurate and reflective of the goals of the program. PVPD input and approval on that message is required.

**Detective / Investigative Contact**: Those charged with use of portal will be trained on how to engage in the Neighborhood conversation, how to post crime alerts and how to request video when investigation criminal activity.

**Legal Contact**: Discussion on video technology, evidence preservation, chain of custody, etc., as well as appropriate (approved) language for messaging Ring Neighbors of this engagement.

Let's plan to touch base soon to discuss next steps. I look forward to seeing you again soon and to working with Paradise Valley Police Department to reduce crime in PV.

#### Term

Agency's participation in the program shall commence upon Agency's acceptance of these program terms. Either party may terminate Agency's participation in the program at any time by providing 30 days' written notice to the other party; provided that in the case of material breach of this Agreement by the Agency, Ring shall only be required to provide three days' written notice to Agency.

#### Privacy and Terms of Use

Ring will not provide any customer personal information, including video footage, to Agency without the prior consent of the owner or properly issued legal process that complies with federal and state law, as applicable. Agency agrees to use the Neighbors Portal only as expressly authorized by Ring and only in connection with bona fide Agency work. Ring's terms of service and privacy notice, as posted on Ring.com, shall apply to all uses of the Neighbors App and, as applicable, the Neighbors Portal.

At no point shall either party receive compensation from each other as a result of this program.


