Leigh Ann and Kristi:

It might be a good idea to give the Executive Committee a couple of date options and then we just go with when the most people can go. Then we will need to contact Kim Dellinger at Metro to set up the room reservation and get the docent scheduled; Leigh Ann, going forward you'll probably want contact Kim directly since you're in charge of OIC Programming. Let me know if you think this is a plan and I can tell her that the OIC contact will be you as head of the Programming Committee and she'll know to be on the lookout for your email.

Again, for our Executive Committee tour there would be a \$20 charge for the docent, no charge for the room but Kim said that she could be flexible on the docent fee. Metro will have evening hours (closing at 8:30 PM) starting on July 19<sup>th</sup> so we could book the tour on a Monday, Tuesday or Thursday night, which I think might be better since so many people work during the day. No charge for parking in the garage at DML Main.

Kim did suggest we get this booked for the week of August 9<sup>th</sup> when the exhibit opens so we'll have flexibility to decide whether we want to book an event space before the exhibit leaves on September 25 or give members plenty of time to view on their own if we decide to host a webinar through OIC or WMPL. But if that's not a good week for very many people, we can do it the next week or so.

Elizabeth, Kristi and Brian:

We talked about this upcoming **Undesign the Redline Exhibit** (August 6-September 25) at Metro as a possible OIC program; it's probably better suited for the Programming Committee but maybe we could support it by hosting a post-tour webinar. It looks like there are a couple of options that might work for groups. The thing is, we don't know the interest with the OIC membership; if we get 20-ish interested, then it could be a docent-led tour that we call the Ask Me Line to book. If we get like 60, then it's an EVENT!! and needs to be scheduled through the Events Manager.

I did talk to Kim Dellinger in Events here about possibilities and here's what she's recommending (and she's recommending we do this the opening week of August 9<sup>th</sup> through the 14<sup>th</sup>):

**FIRST STEP:**

- We start with an OIC Executive Committee and/or Programming Committee docent-led tour
- She books us a COMPED Meeting Room (no charge) + a docent (\$20) for that time
- We can get together in the Meeting Room before the event, then take the tour, then meet afterwards in the Meeting Room to discuss

**THEN:**

- IF WE THINK SELF-GUIDED TOURS for individuals will work, then those can just be booked through the Visit link below
  - We could then host a webinar for OIC participants through WMPL or OIC and recommend they tour the exhibit at their convenience before the webinar
- IF WE THINK IT'S A PROGRAM WE WANT TO HIGHLIGHT, she can talk to us about booking the Community Room, adding a food/beverage package + the docent tour

I actually like the option of the OIC Executive and/or Programming Committees touring first and deciding how we can best proceed. If someone can forward this to Leigh Ann (I don't have her email here with me!), that would be great!

- Meeting was called to order at 3:00 pm.
- Meeting Minutes approved
  - May 18, 2021
  - June 7, 2021
- Treasurer's Report (Newport):
  - Newport is exploring PayPal to allow for online contributions and payments.
    - LCNB has committed to make some charitable donations to the organization.
    - Quarterly written statements from treasurer will be shared with the Leadership Team, an annual Treasurer's report will be posted to the website and shared with community.
    - Treasurer's Report was unanimously approved.
    - ACTION ITEM: Iseli will explore what Sinclair Community College does and if they use PayPal.
- Old Business
  - Community Research Discussion (Iseli)
    - RFP will be sent to the two firms. We are asking for them to send their proposals by the end of July using a rubric Iseli has drafted. Iseli is asking for a small proposal review task force (made up of members of the Leadership Team and Current Issues Committee) to review proposals and provide a recommendation to the Leadership Team.
- New Business
  - Fundraising (Turben)
    - Turben reached out to local banks to solicit donations. Two grant applications were sent as well to Oakwood Rotary as well as the Oakwood Schools Foundation. A gift from Dayton Foundation will be forthcoming. Turben is exploring other grant opportunities.
    - ACTION ITEM: Turben will maintain a list of donors and potential donors for the Leadership Team to reach out to and thank. Donors will also be acknowledged in the OIC's Annual Report.
    - ACTION ITEM: Turben will send draft of thank you letter to Hale for signing and distribution to donors.
  - Changes to Establishing Document (Klopsch)
    - Membership: revisions to the document remove any distinction between affiliate and resident members of the OIC. Instead, membership is open to all.



- Leadership Team: the revisions do not require a specific number of members-at-large for the Leadership Team. There are no term limits for any position.
    - Quorum: Definitions and uses of quorum have been clarified.
    - Annual Reporting: will be provided to Oakwood City Schools and Wright Public Library boards.
    - Revisions unanimously approved.
    - ACTION ITEM: Klopsch and Hale will send revised document to be posted to the website.
  - Community Events (Jackson)
    - Scarecrow Row: Jackson suggested we develop an exhibit for “scarecrow row” for the Fall 2021. Leadership Team would need to be involved in development of project. Having the OIC sponsor or lend logo to a scarecrow will be important as well.
    - Discussions of developing a brochure and getting tables for events (i.e. Ice Cream Social). Some ideas for events include: stickers, book lists.
    - ACTION ITEM: Communications Committee will develop a plan for events in place by Ice Cream Social.
    - Leadership Team had a discussion regarding how to support local- and minority-owned businesses.

### Oakwood Citizens Demonstrate High Interest in Inclusion Coalition

Oakwood citizens are proving their determination to promote a welcoming community for everyone who lives, works, and visits Oakwood. The Oakwood Inclusion Coalition (OIC), a citizen-driven coalition dedicated to inclusivity and diversity, has held two public meetings, and nearly 200 citizens have joined the discussions.

The first meeting held in January was an opportunity for residents to learn about the OIC's vision and mission. Citizens expressed specific activities they would like the leadership team to pursue. The meeting provided citizens the opportunity to share their reasons for living in Oakwood and how they can personally demonstrate a commitment to inclusion, equity, and diversity.

The organization exists for people who want to explore how others' experiences have shaped their values and perspectives. Participants seek to discover and understand rather than persuade. Wright Memorial Public Library Director and OIC Chair Kristi Hale explains, "We want to ensure that everyone's views are represented and respected." Meetings allow residents to speak authentically from their hearts and personal experience. "It's not about 'window dressing,' and its focus isn't political," assures Hale. "It's an openness to community building and a recognition that Oakwood has long benefitted from its citizens' imagining what could be."

The second meeting held in April explored the role assumptions and preconceived notions play when we meet "others" unfamiliar to us. Participants viewed bestselling author Chimamanda Ngozi Adichie's TED Talk and then broke into small groups to consider how their own efforts to make sense of the world lead them to make assumptions. Adichie acknowledges the human naturalness of stereotyping but warns that there is a real danger in making a judgment about a person or group of people based on what she calls "a single story."

One former "West Virginian" participant shared her angst about relocating to Oakwood for employment. Now a longtime Oakwood resident, she is thankful that she ignored her prejudices about Oakwood gained only through the single story she formed about a whole community based solely on her experience with a disagreeable college roommate from Oakwood. Several participants agreed that they had suppressed the negative impressions they conceived before moving here to take advantage of the school system. "It's pretty amazing," said one participant, "how many of us negatively 'stereotyped' our community before we experienced it."

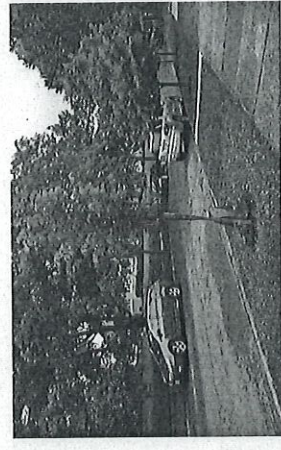
Behind the scenes of the public meeting, the leadership team has gone about the business of establishing a solid organizational framework. Government, school, library officials, private citizens, faith, ethnic and cultural leaders, and representatives from the business and media communities in the Oakwood area have garnered the support of city, school, and library governing boards. The organization's establishing documents and the expectations and code of conduct for OIC participation are on the OakwoodOIC website at [www.oakwoodic.org](http://www.oakwoodic.org).

The Program and Events Committee launched a big read and book club this summer. The Current Issues Committee, best described as the organization's "think tank," plans to qualify and quantify perspectives of Oakwood during this next year. Its objective is to use data-based research to understand the many stories of Oakwood and allow this information to guide the mission and purpose of the OIC. The Communications Committee is working with Wright Library and other Oakwood organizations to increase the resources available on the OIC website to address residents of activities and opportunities advancing issues of inclusivity, diversity, and equity.

The OIC leadership team is deeply grateful for the interest Oakwood citizens have shown in this endeavor.

### Johnny Applesed Tree Planting Project

The city of Oakwood and Oakwood Beautification Committee will again offer trees for purchase through the Johnny Applesed Street Tree Planting Project. Applications and detailed brochures describing the project and the tree species will be available in mid to late September at the OCC and on the City website. Oakwood property owners may choose from four or five varieties of trees. The trees selected will be approximately 2 inches in diameter and will be discounted at 50%. One tree will be allocated for each approved property site at the discounted price but must be planted in the city right-of-way (property frontage). Trees will be planted in the latter part of November or early December. They will be planted by a local nursery, wrapped, staked, mulched and guaranteed for one growing season.
