

## **OIC Programs and Events Committee Report May 18, 2021**

### **General Membership Meeting**

Overall, I have received good feedback regarding our last membership meeting, and I hope the rest of the OIC board has as well.

Here are my questions regarding the general membership meetings:

- Have we given Michael Carter a gift as a thank you for his time? We had discussed several ideas but not sure what (if anything) has been given to him.
- What will we choose for our next topic for next general meeting in July. We need time to line up speaker(s) and advertise our meeting.
- I was surprised our 2<sup>nd</sup> meeting wasn't larger than our first. Could it be the time of year? Several of the folks I invited have church on Wednesday nights—perhaps we think of another week night or alternate night each quarterly meeting? We need to find ways to encourage more people to attend our general membership meetings—the OIC membership is still a lopsided choir it seems.

### **OIC Big Read**

We announced our OIC Big Read at the membership meeting and we have a press release almost ready to send out. I am waiting for volunteer leaders to send me dates for their first book discussion groups to add to the press release. We will have both an adult and youth book discussion groups from mid-June through August, and we hope to offer sessions at various times of day so folks can join a discussion that fits into their schedules.

Here are the needs of the OIC Big Read Program:

- A zoom link for book discussion groups. Not sure we can use Wright Library's for all of these or not. If not, we need to figure out ways to host OIC Big Read online.
- A prominent spot on our webpage for folks to sign up for OIC Big Read updates and book discussion groups. Josh says he can set this up—hopefully this week and possibly with the new web design created by the UD students.
- Leaders for our book discussion groups (both adult and youth discussion groups). Leaders can set day and time for their sessions.

### **Diversity 101 Series**

The first offering of NCCJ's Diversity 101 series was very well received, and several board members requested a summer session. Instead of having a session for only OIC members, NCCJ recommends we join their next community offering starting in mid-July. It is a four-series program, meeting on Fridays 12 – 2 p.m. the weeks of July 16 through August 6. The cost will again be \$100 for all four sessions, or \$30 per session. I will prepare invitation to be sent to our OIC email list after OIC board members have first opportunity to sign up. These sessions tend to fill up fast. Here are my questions for the OIC Board:

- Please let me know if you would like to attend and I will send email with details for registering.
- If you can't attend, would you sign up if it were at another day/time?

*Note: I attended a program similar to Diversity 101 offered by Groundwater out of NC via zoom. It was also very good, but it is much more expensive than the Diversity 101 series. I attended for free through an offer from The Dayton Foundation to its fund advisors/owners.*

### **Film Club**

Before September, the Programs and Events Committee would like to have at least one movie night with a discussion group meeting the following week to share thoughts and ideas sparked by the movie. Having the films shown in a local park could be a great way to get families involved with the OIC.

#### ABOUT THE OIC

The Oakwood Inclusion Coalition (OIC) was formed in 2020. The follow articles from its establishing document describe the OIC's Mission and Purpose:

II. *MISSION*

*The mission of the OIC is to study, promote, and celebrate an inclusive, equitable, diverse and welcoming environment and community for everyone who lives, works, visits, or passes through Oakwood.*

III. *PURPOSE*

*The purpose of the OIC is to foster an inclusive community through education, development of programs and projects, communication initiatives, and regular attention to matters of intra- and intercommunity relations. The OIC is an organization of government, school, and library officials, private citizens, faith, ethnic and cultural leaders, and representatives from the business and media communities in the Oakwood area and beyond. Volunteer officers manage the organization and receive no compensation.*

*While the OIC will deliver a report annually to the Oakwood City Council, the Oakwood School Board and the Board of the Wright Memorial Public Library, no substantial part of the OIC's activities or reporting shall involve the purpose of influencing, modifying, or suspending city, school or library legislation or policies. The organization shall not participate in, or otherwise intervene in any political campaign on behalf of any candidate for public office or any issue put to vote before the public.*

The OIC, which operates as a 501(c)(3) not-for-profit organization, may raise funds to pay for program costs. The organization is led by a Leadership Team that oversees all of the activities of the OIC. The Leadership Team met for the first time in January of 2021. Two public membership meetings have been held since, in January and April of 2021, and several committees have been formed: a Program Committee, a Current Issues Committee, and a Communication Committee.

#### REQUEST FOR PROPOSALS

As per its mission statement, the OIC seeks "to study, promote, and celebrate an inclusive, equitable, diverse, and welcoming environment and community for everyone who lives, works, visits, or passes through Oakwood." As the OIC forms and seeks to develop programs and projects, the key action in beginning its works is to determine how best it can serve the community of Oakwood and adjacent communities in studying, promoting, and celebrating "an inclusive, equitable, diverse, and welcoming environment and community for everyone who lives, works, visits, or passes through Oakwood. Central

to determining the future direction of this work is developing at once a more nuanced and detailed understanding of (1) who lives in Oakwood and how they understand and perceive the city as “inclusive, equitable, diverse and welcoming”, and (2) how Oakwood, its history, its current state, and its present residents are understood and perceived as “inclusive, equitable, diverse and welcoming” by those who are not residents of Oakwood. Receipt and analysis of this information will serve to inform the OIC as it moves forward with its work.

### **PROJECT**

To this end, the OIC searches professional assistance in conducting community research around the questions and matters articulated above that are central to the organization’s mission. Using participatory community research methods, the professional assistance will work with a small group of the OIC to develop and implement research instruments, as well as to provide analysis of the data and reports on the findings of the research.

Specifically, the OIC seeks to understand where Oakwood stands, is perceived, and needs to grow so as to be “inclusive, equitable, diverse and welcoming” by those who live within the City of Oakwood, as well as those who work, visit, or pass through the city. This sampling will include residents of Oakwood as well as from throughout the greater Dayton region, and all sampling(s) should be representative of a full range of individuals and identities so as to provide statistical depth, breadth, and veracity in both quantitative and qualitative data.

The results of this research will be compiled and presented to the OIC Leadership Team, which will then determine the best course of action for the use of the data in informing the organization’s activities and strategic planning for its future work.

### **TIMEFRAME**

Still in its initial stages of development, the OIC wishes to undertake this project so that it is accomplished fully, rather than quickly. The OIC is looking to the proposer to suggest optimal timeframes for conducting this work.

### **PREFERRED PROFESSIONAL ASSISTANCE QUALITIES**

- Experience working in a participatory community research model.
- Understanding of Oakwood as well as the Greater Dayton Region in which Oakwood is located and has had a long history. Ideally, this combined understanding would include awareness of and sensitivity to historical dynamics of the greater region vis á vis Oakwood that have shaped and continue to shape understanding and perceptions of Oakwood vis-á-vis inclusion, equity, diversity and a welcoming presence both within and beyond the city.
- Experience in community research data analysis, reporting, and presentation.

### **PROPOSAL FEES AND OTHER COSTS**

Should the OIC choose to undertake this community research, it will have to raise the funds to pay the professional assistance. This may also require some extra lead time before commencing the actual project.

Meeting was called to order at 4:00 pm.

**Approval of Meeting Minutes:** Cook made a motion, seconded by Iseli to approve meeting minutes for meetings held on 22 March, 6 April, and 28 April 2021. All in favor, none opposed. Minutes will be posted to OIC Website.

**Treasure's Report:**

- Bank Account Access and Funds Disbursement Protocols. We are very close to getting that setup. Will update at next meeting.

**Old Business**

- 28 April Meeting Recap and Plus/Delta
  - Clarify website process of signing up
    - Action Item: HALE will follow up with the website.
  - WIX portal email list was not reliable for everyone who attended.
  - Some participants felt the breakout sessions were a waste of time. Some leaders may have not followed the protocols for small group discussion. Many had excellent breakout sessions. We may have some additional conversations or training for breakout room leaders. We should ensure that breakouts have introductions first.
  - There was a discussion on terminology in follow up communications.
  - Fulford will officially thank Michael Carter from OIC.
    - ACTION ITEM: Fulford will send thank you to Carter
  - Attendance was good (82 people).
  - Many people had a negative impression of Oakwood before moving here. All had their expectations shift once they moved to Oakwood. It illustrated the power of "The Single Story."
- Community Research Discussions (Iseli)
  - Current Issues had questions about the process. Iseli is bringing draft RFP for Community Climate Research. Iseli shared that this kind of data can help guide our organization. Cost for a different RFP from Burgess and Burgess was \$15,000.
  - How will we raise the money for the market study? How do we balance the requests and expectations of the community that donates the money for the study. Data will need to be shared.



- We need to build trust with the firm chosen to ensure the data is collected properly. The relationship between OIC and the firm will be critical going forward.
- We need to identify outcomes and plans for how we will use the data received.
  - Burgess and Burgess and Mary Taylor were suggested as potential individuals/groups with whom we can share the RFP.
- Motion “OIC will pursue an RFP for a Community Research Study” (unanimously approved).
  - ACTION ITEM: Hale will reach out to absent members to ensure they agree with the direction as well.
- OIC Logo/Branding Campaign (tabled)
  - TABLED

### New Business

- Changes to Establishing Document (Norb)
  - Minor wording changes
  - Clarify that the city, schools and library liaisons may also serve in other capacities on the Leadership Team.
  - Specify that the Leadership Team determines by majority vote the replacement of Leadership Team members when needed.

This calendar encourages public awareness of Jewish religious observances. The Jewish Calendar is also called the Hebrew Calendar and follows the lunisolar cycle keeping in sync with the natural cycles of the Sun and Moon; each month begins with a new moon. The Jewish Calendar determines when Jewish holidays begin and end. Our hope is that this calendar will assist with scheduling any events. There is a wide variation of Jewish practices that may determine how individuals and families observe their holidays. Jewish Holidays begin the evening before a few minutes before sundown and conclude the following day with three stars in the sky.

**Shabbat** is the Jewish weekly "day of rest" which begins a few minutes before sundown on Friday and concludes with three stars in the sky, Saturday evening. The Sabbath is considered the most sacred observance in Judaism.

**Rosh HaShanah** (Head of Year) is the Jewish New Year and the first of the Jewish Holy Days marking the beginning of a period of repentance and prayer that ends with Yom Kippur. Rosh HaShanah is observed for either one or two days.

**Yom Kippur** (The Day of Atonement) is when the Jewish people ask for forgiveness for the wrongs committed over the past year. Fasting and refraining from work and leisure provides time and space for deep prayer and reflection.

**Sukkot** (Booths) is a festival marking the time of the harvest. Booths or huts are temporarily erected for sleep, meals, and prayer to commemorate the harvest times of ancient Israel.

**Shemini Atzeret** (Assembly of the Eighth Day) arrives at the conclusion of Sukkot. In Israel, Shemini Atzeret marks the beginning of the rainy season.

**Simchat Torah** (Rejoicing in the Torah) celebrates the conclusion of the yearly reading of the Hebrew Bible and the festivity of beginning the reading again. Simchat Torah marks the end of the fall holidays.

**Chanukah** (Festival of Lights) is a minor Jewish holiday. Celebrated for eight nights, Chanukah commemorates the victory of the Maccabees and rededication of the Temple in Jerusalem. Many different English phonetic spellings of this holiday such as Hanukkah and Hannukah, bring additional notoriety to this well-known festival of lights.

**Purim** (Feast of Lots) is a joyous holiday recounting the saving of the Jewish people from a threatened massacre during the Persian period of 539-330 BCE. The Book of Esther is read during Purim.

**Passover or Pesach** (Passed Over) is one of three pilgrimage festivals of ancient Israel and commemorates the Exodus from Egypt. Passover is celebrated with a ritual meal. Seder, which means order, provides a place for discussion about Freedom and Social Justice. Unleavened bread, known as matzah, is eaten during Passover to mark the time in ancient Egypt when the Israelites had to flee from persecution and did not have time for their bread to rise.

**Yom Hashoah** (Day of Holocaust Remembrance) for those who perished during the Holocaust. This day of Remembrance began in 1953 and is a time for Holocaust survivors and their families to be recognized.

**Yom HaZikaron** (Israel's Memorial Day) honors Israel's fallen soldiers and precedes Israel's Independence Day.

**Yom Ha'Atzmaut** (Israel Independence Day) celebrates Israel's independence from the British Mandate in 1948.

**Shavuot** (Feast of Weeks) is another of the three pilgrimage festivals marking the giving of the Torah at Mt. Sinai.



Thanks for pointing out the link to Other Perspectives with articles on conservative viewpoints. It's good to see you have this, but how do patrons find it on their own? The link could be made more accessible.

Add to your front book display next to the books about racism by liberal writers, books by conservative thinkers. Some authors for example: Shelby Steele, Thomas Sowell, Carol M. Swain, Walter E. Williams, Candace Owens.

Add a bibliography of books on this topic by conservative writers to the other bibliographies you have listed with resources on the OIC site

Finally, include an equal balance of conservative speakers in your programming.

**Old Business**

- 28 April Meeting Recap and Plus/Delta
  - Clarify website process of signing up

  - WIX portal email list was not reliable for everyone who attended.
  - Some participants felt the breakout sessions were a waste of time. Some leaders may have not followed the protocols for small group discussion. Many had excellent breakout sessions.
