Personnel Complaint Investigation

- December 20, 2020 [REDACTED] contacted station about a complaint
- December 21, 2020 [REDACTED] spoke with Chief Blasko
 - Stated that on 12/20 at about 130 PM he was traveling on State Route 302 in the area of Dickerson and he observed a police car traveling at a high rate of speed with his emergency lights activated. The Police car entered his lane of travel causing him to swerve and hit his brakes abruptly.
- [REDACTED] followed up with a completed personnel Complaint Form

The incident was reviewed and Officer Lee was operating 218 responding to an accident (CP-5158-20).

- Initial call was that there was an accident with unknown injuries and call was updated later to advise no injuries.
- Officer Lee was spoken to and he advised that he was across town responding and initially call appeared to be a priority response.
- Officer Lee believes he was driving appropriately but with the location that the complaint stems from, any assertive driving can be troublesome to unsuspecting drivers.
- Officer Lee advised as soon as the call was downgraded he adjusted his response

Conclusion

While Officer Lee's assertive driving was troublesome to [REDACTED] he was within the parameters of department policy and the vehicle and traffic law.

Officer Lee was reminded about call response driving and the effect on other drivers. As far as the allegation of reckless driving he is **Exonerated**.

I spoke to [REDACTED] about the conclusion and advised him that I would be adding the reminder and policy into department cycle training
