After interviewing and obtaining statements from all witnesses identified from the incident that occurred on the 18<sup>th</sup> of July I can report that officers Zavadil and Farrell conducted themselves in a courteous and professional manner when dealing with the suspect [REDACTED]. It has been reported by all three witnesses that [REDACTED]

I personally reviewed the video of the incident and at no time was [REDACTED] subjected to physical contact by either officer and it was observed that [REDACTED] flailed her arms at both officers.

I further interviewed [REDACTED] the DCO from Town of Shawangunk and she reports that's [REDACTED] has many prior cases in their Township and that she has unsuccessfully tried to sue several residents always involving dogs. Additionally she has unsuccessfully tried to get several dogs declared as dangerous dogs. [REDACTED] has also been given trespass warnings now at Agway.

There is no merit to her claims against our officers. In speaking with all the witnesses it was repeated over and over that they were professional, polite, courteous, and respectful. All witnesses requested the officers be commended for the way she handled the situation.

X On Saturday July 18th at approximately 2:30 pm \_\_\_\_\_ entered Pine Bush Away with her dog. When my dog Gus went to greet them (as he usually does with most customers) she screamed at my dog. I removed him from the situation but she continued verbally assaulting me. She said "If your dog would've touched me or my dog, I would fucking kill you." I asked her multiple times to leave the store, which several customers and employees can attest to. She refused and I called the police. She stayed at the front of the store until the police arrived about 5-10 minutes later. The first officer (darker hair) asked me what the issue was and after I told him, he asked her to leave. She began to ask why she was being forced to leave and became belligerent. At that point another officer approached the store from the front walkway to assist the first officer. Once the doors closed, I was unable to hear any conversation but witnessed the officers attempting to calmly bring her to the parking lot. Both officers seemed very calm and acted ~~highly~~ professionally throughout the incident.

After the incident, both officers came back in the store and took statements from all witnesses. They also advised me on proper procedures regarding banning the customer in question from our stores/properties.

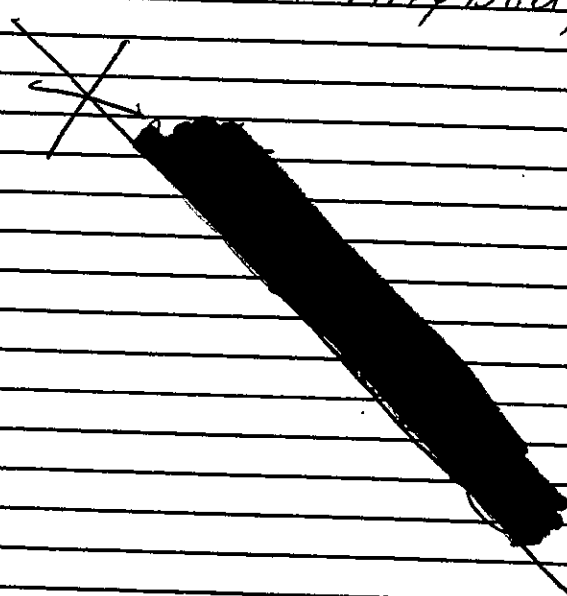

Re: Incident at Agway on Saturday, July 18, 2015

Dear Chief Blasko:

On Saturday, I walked into the Agway store to return some tapeworm medication.

As I entered the store with my registered, licensed service dog, [REDACTED] bolted out from behind the counter and tried to attack me and my dog. I was able to stop the attack, but an employee, [REDACTED] came at me, shouting, cursing, name calling and ordering me out of the store.

I asked [REDACTED] to call the police, in order for me to make a report about his dog attacking me and my dog.

A single police officer arrived, talked to [REDACTED] then approached me and manhandled me out of the store without responding to the plea I made to take a complaint about the dog attacking. When I told him to take his hands off me, the officer stated "I could do a lot worse to you if I want."

A second police officer arrived, and his attitude toward me was even more aggressive; he also refused to respond to the fact that I asked for the police to be called for the dog attack. He said "This is a private store and they don't want you to ever come back here again. Do you understand me, mam? Do you understand me, you are never to come here again. Do you understand me?" I told him that I understand that I am afraid of you cops and that's not good. I told him I wanted to speak to the Chief of Police and he said "We don't have a chief; I am the senior officer involved and you will get out of here."

As I was driving away, I saw the police officer throw his hand up in the air, open his fingers into a "victory" sign, and grinning, saying "bye, bye now, don't come back, bye bye."

I called the police station and was told there was nothing I could do about what happened until Monday. I called the police station again and was told a message would be left for the dog control person to call me; she did call me, and agreed to meet me on Wednesday at the police station to take my complaint.

I am at a total loss to understand why the police treated me the way they did. I depended on them to help me in this matter, and they treated me like a criminal, and then laughed and scorned me. As far as staying away from Agway, it will indeed be a pleasure, and I will be enthusiastic about telling all my friends what happened there.

I look forward to hearing from you, Chief Blasko; I know that were you the officer in charge at the time I would have been treated with great respect because you are an honorable and respectable police officer.
