

As a lifelong educator, and assistant superintendent who oversees our K-12 curriculum, I cannot tell you how exciting it is to see part of our community engaging in such healthy and respectful dialog. This exchange is also aligned to one of the five recommendations made to our Board of Education by our Equity Stakeholder Team. At that June meeting we recommended that our faculty engage in an examination of our curriculum at all levels and in all subject areas. We know that our work in DEI will be strengthened by assuring that our students have access to credible educational materials which represent multiple perspectives.

Knowing this topic has become emotionally charged in neighboring communities, I ask for our Croton-Harmon families to exercise patience at this time. Our Board will only begin to engage in discussion about the recommendations from the Equity Stakeholders Team at their September Work Session. That may provide an initial charge for how our administrative team will begin to work with faculty and the Stakeholder Team. This will be a slow and thoughtful process. By collaboratively and carefully focusing on any needed curricular enhancements, I am confident we will create an even better educational experience for all of our students.



I completely agree with the prospect of having the team's activity move forward with avoidance of political divisiveness and with common goals. That is primarily why I found the specific choice of bringing in Marisa odd: while she has extensive experience in bullying-studies and social-work coordination (very valuable), her work with the Justice for Yorktown group annunciates her activism for very particular left-wing partisan political causes – I would be wary of how that could effect a discussion on allowing or dis-allowing certain ideas, it might serve to create more divisiveness. I simply don't think she's an appropriate person to bring in, especially because we already have really strong people on the team, who are very capable of continuing their already-established discussions and addressing all topics internally.

John, I believe that neither you, nor any of the other leadership within CHUFSD, would do anything to veer away from protecting our students at all levels, and protecting their ability to learn, grow and have their voices heard and respected within our community without un-merited negative recourse. Dear John.

Thank you for the invitation to participate in the World Cafe event on September 9th. I'm writing to express some specific concerns about the event itself and about task force members' potential participation.

First, a significant number of task force members were unable to attend the end-of-summer in-person meeting where this event was first introduced to us. Even though I did attend that session, it's not clear to me how the district came to the decision to hold this event during the second week of school (on the fourth day of school, during a two-day week, to be precise), and how the meeting format was determined. Regardless, it feels as if we are rushing ahead to engage with the larger school community and general Village public before having an internal task-force conversation about our collective aims, the tactics we feel comfortable using to further them, and any unified messaging we'd like to use when engaging with the community at large. My sense from talking to task force members after the August meeting and from reviewing the Thoughtexchange feedback is that more internal discussion is needed before we take these proposals, which we have already presented to the BOE, to the general public for feedback.

Second, I'm concerned that the proposed format of this event -- an in-person outdoor event on school grounds (unclear where the initial presentation will take place,indoors or outdoors?) -- will expose the task force and district to criticism that might impede our progress on this issue. If the district is not allowing parents to gather on-site for events like back-toschool night, some might ask, why are we allowing people to come in-person to a "diversity event"? To me, the optics are not ideal here, and the takeaway might be that a "diversity event" is getting special treatment. I'm also concerned that asking volunteer task force members to individually meet and interface with the community without the concrete partnership of district representatives could potentially expose task force members to psychological and/or physical harm. Bias crimes and verbal assaults against people of color continue to occur with regularity in New York State, and I don't feel comfortable putting my body in the path of someone who might have an axe to grind about DEI issues.

I support the work of the task force, and I'd like to remain an active participant in the group's efforts going forward, but I ask that the district consider postponing this event until the full task force can participate in the discussion about next steps. Dear Equity Stakeholder Team Members,

Although we have not formally convened in a while, it has been an eventful Fall. Thank you for taking a moment to review this recap of events.

BOARD OF ED STUDY SESSION - We are so thankful to the Board of Education for their support of our recommendations. After administrative and legal review, they did undergo some tweaking from our original presentation in June:

- School Climate Consciousness: In order to develop climate consciousness, students, parents. educators, and the community must feel safe, supported, and able to learn and grow together over time in CHUFSD. In order for this to happen, for this assessment of, and response to, the pulse of the lived experiences of district community members, individuals must feel heard and represented, and confident that their story matters.
- Hiring and retention practices: If we want our graduates to contribute to a world that is increasingly more equitable and diverse, we need the environments in which they learn to be a microcosm of that world. Our schools must be a place where all students can see themselves reflected in terms of race, ethnicity, gender, sexuality, religion, language, and ability, in the adult world around them. Every child should have adults with whom they can identify.
- Curriculum: We must strive for a representative, responsive curriculum that attends to the race. ethnicity, language, country of origin, gender, sexuality, ability, culture, and religion of Croton-Harmon students and the community at large, while supporting teachers to create culturally responsive classrooms. This approach must include a welcoming and affirming environment, high expectations

through rigorous instruction, inclusive curriculum and assessments, and ongoing professional learning aligned with the New York State Culturally Responsive-Sustaining Education Framework (2019).

- Professional development: Embed professional development opportunities for all district staff to develop an equity lens. There is a need to be slow and thoughtful in our work and process while at the same time acknowledging that there is an urgency to the work for our students. Through professional development and coaching, our staff will develop shared language, practices, understanding, and tools and grow as teachers and learners.
- · Parent, guardian, & community engagement: We want our children, parents, and community to have access to the full and diverse perspectives that exist within our growing community to learn from each other, and to feel and be included in their education through active engagement.


The BOE should create a policy that clearly states how we intend to (a) listen, (b) communicate, and (c) co-design an engagement strategy for the benefit of students, parents/guardians, and community members at large. The policy should include but not be limited to:

- Offering multiple forms of listening (town halls, emails, posters, multiple languages);
- Varied events and timing with responsive communication; and
- Periodic review of the policy based on student, parent, community feedback.

THANK YOU - Many of you were present at this work session, and your presence was impactful and so deeply appreciated. Your ongoing attendance and advocacy for our work at subsequent meetings is also something that truly makes a difference. I continue to have such gratitude for the time and dedication being put into our efforts.

BUILDING EQUITY TEAMS - Throughout the first semester, our administrative team has been working on the goals we created - particularly the structures that need to be put into place to support our recommendations. A vital structure was the composition of what was originally referred to as our Building Equity Teams. After many iterations we have landed on a model we call Building Equity Liaison Leaders, or our BELL Team.



The BELL Team would consist of twelve individuals, four at each building, who are committed to realizing our goals for their building. Note that a "Fellow" is a teacher leadership position we currently have in place. As the model hopefully communicates, this structure allows the BELL Team to be a conduit between the district visioning we conduct, and the "boots on the ground" work that happens at the building level through the bottom three entities.

UPCOMING PARENT UNIVERSITY - I am also happy to announce that we have been working with the district's Social-Emotional Learning Committee to sponsor a Parent University around the topic of Equity. I believe it will go far in launching our fifth recommendation on parent, guardian, and community engagement.

We have invited Melle Powers to facilitate two sessions on January 11th and 25th at 7PM via Zoom. Our working title for the series is "Reflecting on our Stories: How to have healthy conversations with our children about race." The first session would be an examination of personal identity and communities of belonging. It will be centered on how the stories we tell give us a sense of who we are and how they are connected to narratives that have an impact on culture. This will springboard us into a second session that will help parents build a toolkit of how to comfortably speak with their children when the conversation turns to difficult topics.

CONSULTANT UPDATE - With Natalie Zwerger no longer working at the Metro Center, another facet of our administrative efforts has been to identify another consultant. There are, obviously, many factors we have been considering as we meet with prospective consultants, and the current demand for equity work in schools has presented us with additional, unexpected factors. I wish I had an announcement to make at this time, but after interviewing six candidates, we have yet to identify an individual.

IN CLOSING - As you know, the district is experiencing a transition with the retirement of Dr. O'Connell. Her dedication and advocacy for our equity work has positioned us so nicely for our future. I've been engaging our new superintendent, Stephen Walker, in ongoing conversations on the status of our equity work. I know he is excited to meet all of you as we continue our good work in the new calendar year.

If you are celebrating a holiday season, I hope it is festive and peaceful. I look forward to seeing all of you soon!





We are so grateful for the large turnout at our two-part Parent University entitled "Reflecting on Our Stories: How to Have Healthy Connections With Our Children About Race." This event went far in kicking off our team's recommendations in two identified areas:

- <u>Climate Consciousness</u>: "In order to develop climate consciousness, students, parents, educators, and the community must feel safe, supported, and able to learn and grow together over time in CHUFSD."
- <u>Parent, Guardian, and Community Engagement:</u> "We want our children, parents, and community to
 have access to the full and diverse perspectives that exist within our growing community to learn from
 each other, and to feel and be included in their education through active engagement."

We are also so thankful that many of you took the time to participate in this event and meet its facilitators. In a previous communication I did let you know that the district was very interested in pursuing a relationship with Melle Powers and Melissa Shaw of Powerful Communications, LLC. Your feedback was very helpful in affirming further discussion about their facilitation of our equity work for the remainder of the school year. Here are the top three sentiments shared in the ThoughtExchange we hosted:

I felt this session provided a comfortable human connection with our community. Our ongoing work requires the human connection to truly allow us to relate to one another and to appreciate and honor multiple perspectives.

I feel strongly that Melle and Melissa will be able to hear every voice and help our community better understand the needs around DEI. Some parents have voiced discomfort around the subject of DEI. Facilitators sensitive to our community makeup and these challenges are needed.

This Parent University session with Melle and Melissa was wonderful. I felt that the two women were experienced

facilitators. The subject of race is difficult to discuss, especially in a large group with varying levels of comfort. The women created an open and welcoming space.

I would like to share with you that at this Thursday's meeting, we will be recommending to the Board of Education that they approve an agreement with Powerful Communications, LLC. Subject to that approval by the Board, we will be looking forward to the announcement of our next meeting as well as the next phase of our equity work here in Croton-Harmon.

I wanted to share that I serve on the Hudson River Teachers Center advisory board. They are offering a new program called Eduplanet21. I have included the flyer below. These learning institutes are self-paced and by joining teachers have access to all of the institutes for one year. I thought this was a unique opportunity, but in particular I noticed one learning institute and I plan to complete it. That learning institute is called Rebuilding for Equity and Inclusion. Here is the description of that learning institute. Rebuilding for Equity and Inclusion will take participants' understanding of equity to the next level. The content will focus on strategies and approaches to meeting the unique needs of each student and will combine theory and practice to equip educators with confidence and competence.
