On 9/22/2021, I, Officer King #1208 was working uniformed patrol assigned to the Operations Bureau in a marked black and white CCPD patrol vehicle. At approximately 1320 hours, I responded to a disturbance report at Tik Tok, located at 5800 Bristol Parkway.

Upon my arrival, I met with the reporting party, **contract the second second and a second and a second second and a second**

At approximately 1131 hours, a content creator (later identified as Sebastian Ospina Castro) walked into the aforementioned location demanding to file a complaint. The front desk reception told Ospina Castro that he had to fill out a form. He began to verbally berate and insult the front desk receptionist. Two security guards arrived and attempted to help Ospina Castro. Ospina Castro continued to be upset as security asked him to leave the premises multiple times. Security advised Ospina Castro that he was now trespassing and Ospina Castro exited the building and walked towards the courtyard.

Ospina Castro began to walk towards the building for a second time and the security guards met him in the courtyard before he could get to the doors of the business. Security guard **control security** stated that Ospina Castro began to cry and talk about white privilege and dictators. Ospina Castro said that due to all the dictators in his life he had to purchase firearms. The security guards never saw a firearm but were concerned for their safety.

While at the station, Ospina Castro arrived at the front desk. He seemed very upset and stated that he had just arrived from Miami and went to Tik Tok to talk to a diversity coordinator. Ospina Castro stated that he is a content creator on Tik Tok and has been getting, "Doxxed" by other profiles on Tik Tok. Ospina Castro believed that Tik Tok was liable for any of the libel happening to him. Ospina Castro stated that he did not bring a firearm with him but that he does have firearms in Miami.

Using departmental resources I was unable to confirm if Ospina Castro has any firearms registered to him.
