I responded to the incident location on March 7, 2018 at 12:05 a.m. with Deputy Director Erick Baltazar and Attorney John Alden. Animal Care and Control took custody of a black puppy shortly after we arrived. We were informed of the following preliminary information: Officers were conducting a 211 felony stop of three suspects. Nine officers used firearms. Seven officers witnessed the shooting. I participated in a walk-through. Cars 157, 139, 167, 124, and 095 were involved. The front driver and passenger side doors of 124 were open. A bullet hole in the front passenger side door of 124 appeared to have been shot outward. Gouges in the hood of 124 appeared to have been caused by bullets. The trunk of car 167 was open. The trunk of the suspect's car was open. The rear window of the suspect's car was shattered. A handgun was inside the trunk in the left corner closest to the bumper. There were several other items in the trunk that appeared to include clothing. There appeared to be a smear of blood on the barrel. I noted addresses of possible witnesses for canvassing purposes (lights were on in several windows). An officer took a crime scene video at 1:30 a.m. There were no signs of homeless encampments on the block. At one point, I noticed that an officer standing with





an agitated man at the edge of the crime scene tape on 22nd Street and South Van Ness. It appeared to be the same man who had walked past crime scene tape as were arriving.

One round of ammunition from a 9mm handgun was also recovered.

- The family stated that there were witnesses/bystanders that were nearby during the shooting and • were never taken to a safe area
- SFPD stated in their incident report that it was a traffic stop which was contrary to what happened. •
- The family felt based off of the BWC footage that Adolfo was being given mixed commands from various officers on scene. The family stated officers can be heard yelling, "show me your hands" and then yelling, "stop moving". The family felt that Adolfo was confused by this.
- The use of the ERIW [bean bag round] when the situation was at a standstill. .
- There was not a certified translator on scene. The family brought this up after Adolfo's sister • mentioned that Adolfo spoke, "perfect English".
- The phrase, "put the gun down" was never used.
- The driver can be heard yelling, "we didn't do anything!" in the body worn camera footage. •
- Based off the body cam footage that has been released, the family there was no one in charge on • scene.
- Adolfo was hit with a bean bag when he was, "already complying" •
- Chief Scott told the family that the officers involved in the shooting are already back on duty which • upset them.

The family also wanted to know how many bullets were fired from Adolfo's gun. The family and representatives were provided with DPA brochures and left at around 1:20 p.m.
