The Cedar-Wapsi Unit was assigned to Hardin County. So if you have any questions let Justin Clark or me know.

I am forwarding you 2 emails Seth Moore with DNR Sovereign Lands Permitting Section received asking about doing some exploring for a potential CO2 pipeline in Hardin County. There is a chance that the potential pipeline may go across public land. Because this is a feasibility survey it is expected this permit will be approved without much issue. You may be contacted to allow access on public property by the company mapping out the pipeline route. Otherwise I don't know much more about it than that.

Once the pipeline route is mapped they will need to apply for construction permits and the DNR and CCB can make more comments about potential threats to habitat and rare species then.
