Alderman Gewirtz referenced an article published in the Boston Globe on April 6, 2014 regarding the success of implementing a \$0.05 fee for single-use plastic bags. She stated she would like to find out what other communities have done and identify best practices. She commented on the success of the city's plastic bag recycling program and stated she feels people will move quickly to reusable bags once a plan is in place. Alderman Niedergang asked that he be added to the order and suggested the City Solicitor investigate whether the city can regulate the use and recycling of the plastic bags associated with free advertising circulars. President White said that the City Solicitor is working on that issue and a recommendation should be forthcoming.

Mr. Buckley spoke about ordinances in other communities and said that he believes that such an ordinance in Somerville would be defensible. He noted, however, that placing a deposit fee on plastic bags would be problematic. Members discussed the legislative process involved and the timeline and Mr. Boukili requested that the item be kept in committee until a new Environmental Programs Manager is hired.

Alderman Gewirtz suggested modeling Somerville's ordinance after Brookline's and recommended a threshhold of 5,000 (or more) square feet. Members made various recommendations and requested that the Law Department prepare a draft ordinance for the committee's review.

Mr. Buckley reported that 5 other MA towns are taking similar actions. All were reviewed by the Attorney General's Office and approved as being within the authority of selectmen, etc. and being a proper use of its policing powers. Mr. Buckley reviewed a draft ordinance that mirrored Brookline's and pointed out that Somerville already has 3 ordinances dealing with plastic bags. Alderman Gewirtz suggested that the fines be changed to increase the 2nd offense to \$100 and the 3rd to \$300, without limiting the city's ability to impose fines within a certain time period.

Alderman Niedergang discussed how manufacturers might avoid being affected by this ordinance by changing the thickness of their plastic bags. The detrimental effects of some compostable and/or biodegradable bags were also discussed. Mr. Sellers-Garcia spoke with Brookline's Public Health Director and was told that compostable/biodegradable bags not readily available. Brookline observed that, after enacting its ordinance, it appeared that plastic bag use was entirely replace by paper bags, (although there is no factual data on this). Ms. Lowitz spoke about the litter caused by plastic bags and suggested that compostable/biodegrade bags would probably still end up as litter.

Currently, there are 200 cities/towns in 17 states banning plastic bags. Chairman Ballantyne will schedule a public hearing on the matter.
